# **DECISION**

PARCHADHARI LLC D/B/A E MARKET CONVENIENCE & DELI 285 WASHINGTON STREET EASTON, MA 02356 LICENSE # 90716-PK-0368

**VIOLATION DATE: 3/26/2025**

Parchadhari LLC d/b/a E Market Convenience & Deli ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a hearing on Tuesday, May 20, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Smith & McDonough's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators Smith & McDonough's Minimum Purchase Age Compliance Check Field Report, 3/26/25;
- 2. ABCC Licensing Authority Certification, New License Approved 1/30/2024;
- 3. Licensee's Stipulation of Facts.

### FINDINGS OF FACT

- 1. On Wednesday, March 26, 2025, at approximately 4:30 p.m., Investigators Smith & McDonough ("Investigators") conducted a compliance check at Parchadhari LLC d/b/a E Market Convenience & Deli.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 25-ounce can of Bud Light beer for four (\$4.00). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2024.

#### CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING**.
