DECISION

PMB HENNESSEY'S CORP. D/B/A HENNESSEY'S LIQUORS 589 WASHINGTON STREET EASTON, MA 02356 LICENSE # 89944-PK-0368

HEARD: 5/27/2025

PMB Hennessey's Corp. d/b/a Hennessey's Liquors ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a hearing on Tuesday, May 27, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators McDonough & Smith's Minimum Purchase Age Compliance Check Field Report.

The following documents are in evidence:

- 1. Investigators McDonough & Smith's Minimum Purchase Age Compliance Check Field Report, 3/26/2025;
- 2. ABCC Licensing Authority Certification, Transfer of License Approved, 2/5/2021;
- 3. Licensee's Stipulation of Facts.

FINDINGS OF FACT

- On Wednesday, March 26, 2025, at approximately 4:04 p.m., Investigators McDonough & Smith ("Investigators") conducted a compliance check at PMB Hennessey's Corp. d/b/a Hennessey's Liquors.
- 2. An underage operative, working under the supervision of Investigators, purchased an alcoholic beverage, one 6-pack of Bud Light beer for twelve dollars (\$12.00). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2021.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. As a result, the Commission issues a **WARNING.**
