After a hearing on April 29, 2025, the Commission finds PMB Hennessey's Corporation d/b/a Hennessey's Package Store violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age (1 Count).

The Commission SUSPENDS the license for a period of one (1) day to be served.

The suspension shall be served on Monday, October 6, 2025. The license will be delivered to the Local Licensing Board or its designee on Monday, October 6, 2025, at 9:00 A.M. It will be returned to the licensee on October 7, 2025.

You are advised that pursuant to the provisions of M.G.L. c. 138 § 23, you may petition the Commission to accept an offer in compromise in lieu of suspension within twenty (20) calendar days following such notice of such suspension. If accepted, you may pay a fine using the enclosed form which must be signed by the Licensee and a Massachusetts Licensed Accountant.

You are advised that you have the right to appeal this decision under M.G.L. c. 30A to Superior Court within thirty (30) days upon receipt of this notice.

DECISION

PMB HENNESSEY'S CORPORATION D/B/A HENNESSEY'S PACKAGE STORE 589 WASHINGTON STREET EASTON, MA 02375

HEARD: 4/29/2025

PMB Hennessey's Corporation d/b/a Hennessey's Package Store ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("ABCC" or "Commission") held a hearing on Tuesday, April 29, 2025, regarding an alleged violation of 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age (1 count). Prior to the commencement of the hearing, the Licensee stipulated to the facts alleged in Investigator Di Cicco's Report.

The following documents are in evidence:

FINDINGS OF FACT

- 1. On Friday, September 20, 2024, Investigators Temple and Di Cicco ("Investigators"), inspected the business operation of PMB Hennessey's Corporation d/b/a Hennessey's Package Store.
- 2. At approximately 6:40 p.m., Investigators observed a motor vehicle containing four youthful appearing individuals enter the parking lot. Investigators observed one youthful appearing passenger exit the vehicle and enter the licensed premises. Investigators then observed the same individual exit the premises in possession of one 18-pack of Michelob

Ultra beer, one 12-pack of Simply Spiked Lemonade, and one 10-pack of 50 ml bottles of New Amsterdam vodka. Investigators approached the vehicle, identified themselves and asked to see proof of legal age to purchase and/or possess alcoholic beverages.

- 3. Underage #1, actual date of birth 11/03/2005 (age 18), provided to Investigators a fraudulent Missouri driver's license bearing his name but a different birth date which he stated he used to purchase the alcoholic beverages.
- 4. Investigators later spoke to the clerk on duty and the store manager, informed them of the violation and that a report would be filed with the Chief Investigator for review.
- 5. The Licensee has held a license under M.G.L. c. 138, § 15 since 2021 with one previous violation.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2)- Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age (1 count). Therefore, the Commission suspends the license for a period of one (1) day to be served.
