SECTION 1

1. HOURLY RATES AND CHARGES

1.1. Rates

Our moving services are billed on a 'straight time' basis, with a minimum hourly charge as set out below plus travel time. The clock starts at the appropriate hourly rate when the movers arrive at the job site and begin providing service, and the clock stops when the movers finish providing service on location.

1.2 Travel time

Travel time: is the travel time from our warehouse to customer pick up address and from delivery address back to our warehouse.

1.3 Overnight Storage Fees

20 ft. box truck: \$250 per night, per truck.

26 ft. box truck: \$350 per night, per truck

1.4 Minimum hourly charges

Customers will be charged a three-hour minimum, including travel time, and then in fifteen minute increments thereafter.

1.5 Cancellation Policy

If customer cancel within 48 hours of their move, Easy Moving LLC, will charge a single hour of the appropriate hourly rate.

SECTION 2

2. Additional services

2.1 Piano moving

The charges are the same as the appropriate hourly rate and minimum charge terms.

Additionally Easy Moving LLC applies following fee:

- Upright piano, Spinet piano, Console piano: \$120
- Baby grand piano and grand piano: \$240

2.2 Elevator or stair carry

Easy Moving LLC does not charge customers an additional fee for elevator or stair carry. The charges are the same as the appropriate hourly rate.

2.3 Right to decline to move items

Easy Moving LLC reserves the right to decline, at its sole discretion, to move particular items because of their bulk, weight or fragile nature.

2.4 Bulky items

Moving overly large or unique items can result extra charges in addition to hourly rate.

Items between 200-300 pounds: \$60 charge per item

Items between 300-400 pounds: \$120 charge per item

Items between 400-500 pounds: \$160 charge per item

Items Over 500 pounds: \$240 per item charge per item

2.5 Excessive distance or long carry charges

Easy Moving LLC does not charge customers an additional fee for carrying articles an excessive distance, long carry charges, articles, or special serving. These charges are the same as the appropriate hourly rate.

2.6 Packing and unpacking charges

We do not charge an additional fee for packing and unpacking. The packing rate is the same as the hourly rate. Packing materials must be provided by the customer. Easy Moving LLC does offer moving supplies for sale; however, these must be purchased separately and are not included in any hourly charges. We are not responsible for items packed by the customer. Boxes containing fragile or breakable items must be properly labeled. We reserve the right to decline any moves consisting of extremely large or fragile items.

Section 3

3. Rules and regulations

3.1 Claims

3.1.1 All claims for loss, damage or overcharge must be written and should be attached to the Bill of Lading. Claimants must immediately notify the carrier of all claims for concealed damage. Easy Moving LLC must be given a reasonable opportunity to inspect damaged items in original packing.

Although our movers will be careful with your possessions, from time to time damages may occur. If damages are caused by our service, we reserve the right to repair the damage(s) in question. If we determine that damages cannot be repaired, we reserve the right to either replace or compensate (actual cash value)for the damage. If there is damage, notify us immediately. Our movers will complete a Damage Report before they leave your site. If you discover damage after the move, call the office within 96 hours of your move. No damage claims will be honored until the charges for moving services are paid in full.

In consideration of the rate charged it is mutually agreed and understood that the liability of Easy Moving LLC with respect to loss and/or damage of the consigned goods is limited to 60c per pound. Easy Moving LLC shall not be liable in any event for any special or consequential damages including but not limited to loss of profits, income utility or market whether or not Easy Moving LLC had knowledge that such damage might be incurred

3.2 Release of liability

3.2.1 Items of particular value

We do not assume any liability whatsoever for documents, currency, credit cards, jewelry, watches, precious stones or articles of extraordinary value including accounts, bills, deeds, evidences of debt, securities, notes, postage stamps, stamp collections, trading stamps, revenue stamps, letters or packets of letters, alcoholic beverages, firearms, coin collections, articles of peculiarly inherent or intrinsic value, precious metals or articles manufactured there from. We will not accept responsibility for safe delivery of such articles if they come into our possession with or without our knowledge.

3.2.2 Pressed-board, particleboard and/or engineered wood

Furniture manufactured from pressed-board, particleboard and/or engineered wood (such as IKEA furniture) are designed by the manufacturer to be transported unassembled in cartons to the retailer, and then to the customer (end user). It is not designed to withstand the normal stress of a move as an assembled unit. Surface impressions can be made on the furniture when writing without adequate support underneath the paper. We will exercise reasonable care in moving this type of furniture, but cannot guarantee that it will be delivered in the same conditions it is in prior to the move. As such we do not assume any liability whatsoever for furniture manufactured with such materials.

3.2.3 Items unable to be assessed prior to handling

The following items are excluded from moving and storage liability due to our inability to assess the conditions of these items prior to handling. If these items are transported loosely, they are excluded from moving and storage liability. These items include, but are not limited to: electronic components, appliances, televisions, stereos, DVD players, CD/MP3 players, sewing machines, typewriters, computers, laptops, etc.

3.3 Bill of lading, contract terms, and conditions

Each customer will be provided with a copy of Easy Moving LLC Moving Services Agreement. The terms and conditions of the Moving Services Agreement are hereby incorporated by reference.

3.4 Delays

Easy Moving LLC shall not be liable for any damages resulting from delays in transporting household goods resulting from an act of God or fault or neglect of any unforeseen entities.

SECTION 4

4. INSURANCE OPTIONS

4.1. Released value protection

Released Value Protection is offered at no additional charge, but the protection is minimal. Under this option, the Easy Moving LLC is responsible for no more than 60 cents per pound per article. For example, if Easy Moving LLC lost or damaged a 50 inch TV weighing 25 pounds, you would only receive \$15 (60 cents x 25 pounds).

4.2. Full value protection

Full value protection is only provided by Easy Moving LLC for interstate moving as required by the Federal Motor Carrier Safety Administration. For full coverage on intrastate moves we refer you to an affiliate company that will provide that coverage.
