1. Maxay la micno tahay in musharax la helo "Aan Ku Habooneyn" sababtoo ah ku guuldareysiga ah inay ka jawaabaan? Go 'aaminta ku habboon ma la sameeyay?

Haa, go 'aan sax ah ayaa la sameeyay. Iyadoo la raacayo 606 CMR 14.14(7), EEC waxay sameysaa go 'aan "Aan Ku Habooneyn" oo ku saleysan ku guuldareysiga cadsadaha inuu ka jawaabo. Marka musharaxa la helo "Aan Ku Habooneyn" sababtoo ah ku guuldareysigooda ah inay ka jawaabaan, looma ogola inay ka shaqeeyaan ama ku biiraan barnaamijka shatiga EEC ama la maalgeliyo. Haddii ay hadda ka shaqeynayaan ama ku xiran yihiin barnaamij shati leh ama la maalgeliyay, waa inay joojiyaan 14 maalmood gudahood. Iyada oo musharrax FCC ah, mar dambe kuma noolaan karaan ama si joogto ah uma booqan karaan guriga barnaamijka FCC iyo bixiyaha FCC ma sii furnaan karo marka uu jiro xubin qoyska ka mid ah ama qof si Joogto ah ugu sugaran Dhismaha "Aan Ku Habooneyn."

2. Sidee musharax u cadsadaa muddo kordhin 30-maalmood ah si uu u dhammaystiro cadsigooda BRC?

Musharaxaa ayaa wici kara Xarunta Xiriirka ee EEC 617-988-7841 si uu u cadsado muddo kordhin 30 maalmood ah, haddii ay sidaas sameeyaan 120 maalmood gudahood ka dib markii lagu meeleyay Dib u eegis Ikhityaari ah. Codsii kasta waxaa loo maareeyaa si shaqsi ah.

3. Miyaan musharaxaa laga helay "Aan Ku Habooneyn" sababtoo ah ku guuldareysigooda in ay ka jawaabaan mar kale cadsan kartaa BRC ah?

Haddii tani ay tahay markii ugu horreysay ee la helo musharax Aan Ku Haboonayn inuu ka jawaabo, waxay dib u codsan karaan wakhti kasta iyagoo soo gudbinaya codsi cusub oo BRC ah. Barnaamijyadu waxay u baahan doonaan inay helaan foom cusub, oo oggolaansho ah oo saxiixan oo ka yimid musharaxa ay doonayaan inay dib u soo galaan. Musharixiinta dib u codsada waa inay dib u bixiyaan dhammaan khidmadaha la xiriira. Dhammaan musharixiinta mar kale codsanaya mar dambe uma qalmaan nooc kasta oo shuruud ama xaalad ku meel gaar ah. Qaybtan musharixiinta waa inay ka baxaan barnaamijka iyo/ama aan ku xirneyn barnaamij inta ay sugayaan go 'aan ku habboon.

4. Sidee ayuu barnaamiju dib ugu soo galayaa musharax haddii marka hore loo galoo Maareeyaha BRC?

Dhammaan musharixiinta hadda waa in laga soo galaa Barta Barnaamijka Hagaha BRC.

5. Miyaan musharaxa laga helay "Aan Ku Habooneyn" sababtoo ah ku guuldareysigooda in ay ka jawaabaan racfaan ka qaadashada helitaankooda Aan Ku Haboonayn?

Maya. Murashax la helay "Aan Ku Habooneyn" sababtoo ah guuldaradii **ugu horreysay ee** ay ka jawaabaan ma xaq u yeelan doonaan racfaan maadaama ay dib u codsan karaan wakhti kasta (*Eeg 606 CMR 14.14 (7)*).

6. Maxaa dhacaya haddii murashax uu codsaday BRC oo aan la raacin marar badan?

Haddii murashaxu soo gudbiyay codsi BRC ah oo aan ka jawaabin hannaanka BRC dhowr jeer, waxaa laga heli doonaa inaysan ku habboonayn waxaana laga yaabaa in laga mamnuuco inuu dib u codsado muddo saddex sano ah.
