

Fiscal Year 2026 Child Care Financial Assistance Daily Reimbursement Rates

STANDARD DAILY BASE RATES

EEC will reimburse providers up to the base daily reimbursement rate shown on the rate charts below depending on the region and type of care provided, unless the provider is also eligible for an add-on rate detailed below. All Infant, Toddler, Preschool, Family Child Care, and Full Day Rates for School Age, Head Start, and Kindergarten assume full-time reimbursement for up to 10 hours of care per day. Part-time care is 5 or fewer hours of care per day. Reimbursement for part-time care is 60% of the full-time rate.
