Re: Notification of Anticipated Siting Board Meeting

The Energy Facilities Siting Board (“Siting Board”) anticipates conducting a remote Siting Board meeting in the above-referenced proceedings using Zoom videoconferencing on **Wednesday, May 10, 2023, at 10:00 a.m.** The Siting Board intends to issue Tentative Decisions in Cranberry Point, EFSB 21-02/D.P.U. 22-59, and Medway Grid, EFSB 22-02/D.P.U. 22-18/22-19, on April 26, 2023.

The purpose of the Siting Board meeting is:

1. to listen to comments, deliberate and vote regarding the limited issue of Siting Board jurisdiction common to both Cranberry Point, EFSB 21-02/D.P.U. 22-59, and Medway Grid, EFSB 22-02/D.P.U. 22-18/22-19; although these are separate docketed matters, the Siting Board anticipates deliberating and voting concurrently on the common jurisdictional issue; and
2. to consider the disposition of the currently referred and consolidated dockets: (A) a petition by Cranberry Point pursuant to G.L. c. 40A, § 3, for a comprehensive zoning exemption from the operation of the Town of Carver Zoning Bylaws; (B) a petition by Medway Grid pursuant to G.L. c. 40A § 3, for individual and

comprehensive exemptions from the Town of Medway's Zoning Bylaws, and (C) a petition by Medway Grid pursuant to G.L. c. 164, § 72, to construct a new 345 kV underground transmission line to connect the proposed Project to the West Medway Substation.
