

# **Opening Remarks**



#### 2024 Climate Act

- Reform the siting and permitting process for clean energy infrastructure facilities (solar, wind, batteries, associated transmission & distribution infrastructure)
- Improve speed & efficiency of permitting process to help achieve the ambitious climate and clean energy goals of the Commonwealth
  - (Expected) increase in # of projects
  - Consolidated permitting of Clean Energy Infrastructure Facilities (CEIF)
  - More meaningful community & stakeholder engagement in pre-filing and review processes
    - New Intervenor Grant Support Program created
- Create a new infrastructure category: Clean Energy Infrastructure Facilities (CEIF)
  - Facilities classified as either small CEIF or large CEIF





Opt-in		Small T&D can seek Consolidated Permit from EFSB; Small generation & storage can seek Consolidated State Permit from EFSB











#### **New Features of Permitting Process**

- Consolidated Permit for large CEIF (all local, regional, and state permits and approvals) and opt-in
- Mandatory review deadlines
  - If deadlines are not met, constructive approval (12 or 15 months)
- New pathways established for projects to move from local permitting process to decision from EFSB Director (De Novo Adjudication)
- New roles and improved communication/coordination between state, regional, and local permitting agencies
  - Permitting agencies will provide input on permit conditions (recommended conditions) and are responsible for enforcement



#### Changes to the EFSB

- Decision-making body for applications to construct energy facilities
- 2024 Climate Act increase in Board membership, and
- Adds new required considerations, such as:
  - Formal requirement for Board to follow the hierarchy of avoid, minimize, and mitigate project impacts
  - Formalizes additional longstanding policy considerations including: labor, economic & environmental justice and equity, public health, and safety
  - Requires consideration of recommended permit conditions by Local Government and other state agencies
  - Cumulative impact analysis for all projects reviewed by the Board
  - Reasonably foreseeable climate change impacts



#### **General Application Process**





#### **Pre-filing Consultation and Engagement**

- Overseen by DPU Division of Public Participation (DPP)
- Provides expanded opportunities for community input into project design, greater transparency, and access to project information via multiple outreach channels
- Establishes pre-filing requirements for Applicant to:
  - Consult with the MEPA Office, state, regional, and local permitting agencies
  - Engage with key stakeholders and conduct community outreach
  - Hold at least 2 public meetings, create a project webpage, provide project updates via email
- Provides flexibility in the duration for completion of pre-filing requirements
  - Requires submission of Pre-filing Engagement Status and Completion Checklists
  - Requires pre-filing notice to be submitted no less than 45 days and no more than 90 days before filing Application with the Board




#### **Consolidated Permit Application**

- Clear, uniform standards applied throughout permit review process (e.g., evaluation of application completeness)
- Extensive guidance document(s) → well-organized, informative, clear, and consistent submissions
- Compilation of previous permit requirements and informational requirements unique to EFSB decisions
- Uniform set of baseline health, safety, environmental and other standards
- Completeness determination within 30 days of filing—begins review timeframe (15 months for large and 12 months for small)

#### Intervenor Support Grant Program

- Intervenors have a formal role in influencing decision making in a proceeding
- Intervenor Support Grant Program will:
  - Provide grants to community groups and other eligible entities who are unable to participate in DPU or EFSB proceedings due to financial hardship
  - Enable diverse voices to represent their interests
  - Allow grantees to cover fees for attorneys, expert witnesses, community experts, administrative, and other eligible expenses
- Regulations detail eligibility criteria, grant application process, maximum grant amounts, eligible uses of funding, and reporting requirements



#### **Constructive Approvals**

- Automatic approval of a Consolidated Permit Application if mandatory Board decision timeframes are not met
  - "Notice of likelihood of constructive approval" issued if Presiding Officer evaluates proceeding progress and determines compliance with timeframe is unlikely
  - Draft Constructive Approval Permit and comment period
- Ensures a final decision is issued within 12- or 15-month timeframe
- Constructive Approval includes "Common Conditions," which are based on facility type and size, and may have a process for considering supplemental, project-specific conditions



#### De Novo Adjudication

- 2 possible pathways for Consolidated Local Permit
  - Request from Applicant or other person substantially and specifically affected by an adverse final decision of Local Government
    - 6-month timeframe
  - Request from a Local Government that lacks the resources to process an Application
    - 12-month timeframe
- Final Decision by EFSB Director
- Opportunity to resolve issues with the municipality-led Consolidated Local Permit process

Local Government completes review of Consolidated Local Permit Application and Issues Its Final Decision

#### **Cumulative Impact Analysis**

- Cumulative Impact is the combined effect of past and present private, industrial, commercial, state, or municipal projects, operations, development, and other economic activities, in addition to the effect of the proposed Project on: (1) the environment; (2) public health; and (3) reasonably foreseeable effects of climate change.
- Burdened Area is defined as a Census Block Group where specified environmental, public health, sensitive populations, and socioeconomic indicators are elevated and could be further impacted by the Project
- Guidance developed by OEJE
- Determine whether the Facility Boundaries, plus a buffer distance, overlaps with Burdened Areas
  - Burdened Areas identified in statewide map based on public health, environmental, and socioeconomic data on a statewide percentile basis
- Applicant required to evaluate whether project would likely cause any disproportionate adverse effects in Burdened Areas and propose remedial actions for such Burdened Areas
- Applicant shares results of analysis with stakeholders during pre-filing engagement activities

#### **Site Suitability Assessments**

- Guidance developed by EEA
- Use of publicly available datasets/tools to evaluate sites based on the following criteria: climate change resilience, carbon storage/sequestration, biodiversity, agricultural resources, and social & environmental burdens
- Applicants estimate scores during pre-filing and share with stakeholders to allow time for changes to project design or use of alternative sites
- Results considered in review/adjudication of Consolidated Permits
