- c) Legal Counsel Counsel indicated nothing to report. A question arose regarding how board member seats must be designated. He noted that the current law does not mandate most members to be licensed, this was changed about a decade ago, when almost every seat required Board issued licenses.

He indicated he was concerned the Board members needed to take an active role in reviewing and approving applications. He further indicated that the Board was welcome to take an additional role if there was as specific element of the applications the members wanted to review, but advised against just reinstating a ratifying vote without clarifying a specific element of review.

 - **d)** Planning and Research Subcommittee J. Bagni reported that the Committee will meet to review outstanding Board policies.
- 7) Discussed Journeymen with Inc. or LLC/LLP business entities registered with the Commonwealth Secretary of State Office
 - The Executive Director stated based on consulting Board Counsel, the law mandates that journeyman licensees cannot conduct business as a corporation, LLC or LLP so suggests drafting an advisory for publication.
 - After discussion the Board agreed to refer the matter to the Planning and Research subcommittee to work on an expansive advisory and FAQs that would include other common recurring subject to Board review.
- 8) Discussed Out of Country education and experience with respect to the Exam Application Process and requirements in 237 CMR 13.00 & 22.00. The Executive Director reported he gets many questions from out of country applicants, he advises them that they should consult with providers and only submit applications when they meet the explicit requirements in the regulations.
- 9) Discussed other matters not reasonably anticipated 48 hours in advance of the meeting.
 - E. Dorian requested the Board extend an invitation to the recently replaced Board members to attend the September meeting in gratitude of their contributions on the Board. The Executive Director agreed to send the invitation.

 - The Chair swore in the parties giving testimony, accepted the exhibits, and gave each party an opportunity to present their position. The Board did not engage in any deliberation during the open session. The Chair advised the parties that the written decision would be disseminated within 45 days.
