7. Board of Electricians' Appeals [open hearings, closed deliberations per M.G.L c. 30A, §18]

a) BEA-21-000007 The Party Trust v James Perry, Town of Halifax

The parties giving testimony were sworn in, exhibits accepted, and each party was given an opportunity to present their position. The Board engaged in no deliberation in open session. Concluding the hearing at 11:22 A.M. J. Colleary made a motion P. Malagrifa seconded, and the Board unanimously voted to close this hearing and deliberate in quasi-judicial session. The chair advised the parties that the written decision would be disseminated within 45 days.

8. Executive Session (M.G.L. c. 30A, §21 – Closed session)

The chair announced that the remaining agenda items would be in closed session and the Board did not anticipate any matters for open session and would be adjourning upon conclusion of Investigative Conference. The chair then closed the public portion of the meeting and the Board commenced quasi-judicial session for appeals.

At 11:53 A.M., J. Bagni made a motion P. Vigneau seconded, and the Board unanimously voted to enter Executive Session to discuss individuals character, rather than competence as well as pending litigation per M.G.L. c. 30A, §21. The chair noted that after the Executive Session, expected to last 15-30 minutes, the Board would discuss matters in Investigative Conference and then adjourn, the Board would not be returning to open session.
