5. **Discussion** Business License related progress and questions

a) E-Licensing Manager update with Q&A

J. Bagni and B. Driscoll spoke regarding the purpose for the business license and a concern with not having the business license distinguish between electrical and systems work. DPL ELicensing manager Leija Meadows addressed the Board regarding a possible C1 business license type for systems. She believes that it can be accomplished at no extra cost to the agency pending Commissioner final approval, but will research the matter further. Staff indicated that they will continue to work to facilitate the business licenses, including correcting errors and communicating with licensees, and will be ready if a systems business license is created. No formal action taken.

b) Reviewing MA requirement of holding a Journeyman after obtaining the Master license.

The members discussed the current need for a master licensee to continue to hold a journeyman license. Counsel stated that this would require a statutory change. He noted that there are many factors in such changes, such as cost analysis, implementation requirements, as well as the steps for getting a law change. The chair recommended keeping the matter for ongoing discussion by the Board. No formal action taken.

6. **Discuss** Inspector of Wires Advisory Notice – The October voted advisory was presented with a new supplemental advisory to explain to homeowners what to do about unlicensed work. The Executive Director stated that the prior advisory was submitted in October for posting however it is still awaiting administrative review, adding that the amended advisory would likewise be submitted as voted by the Board for posting.

J. Bagni made a motion P. Vigneau seconded and the Board unanimously voted to approve the additional advisory.

7. **Discussion** COVID related Education program requests and progress – D. Edmonds updated the Board regarding remote education programs. He indicated that there may be a desire to discuss shop time in the future, and that otherwise current approved programs are working. No formal action taken.

8. **Discuss** DESE related updates and objectives – D. Edmonds stated the Department of Elementary and Secondary Education will present updates on the four frameworks used to

educate vocational electrical students at the January meeting; he indicated a request that the Board entertain a 2 hour presentation. No formal action taken.

- a) J. Bagni mentioned that certain towns have instituted an additional permit fee for work that has already commenced. Counsel stated that as long as it is labeled a fee and not a fine, it would not appear to be a matter within the Board’s jurisdiction.
- b) B. Driscoll noted that the examination review by subject matter experts is ongoing.

The parties were sworn in by the chair and exhibits read into the record. Each party was given a chance to make their presentation, however, the Inspector failed to attend. Upon conclusion of the appellants presentation, at 1:24 PM, J. Bagni made a motion P. Vigneau seconded and the Board unanimously voted to adjourn the hearing and enter deliberations.
