- 5) Discussed subcommittee meetings and reports:
  - a) Regulation\CMR Subcommittee No meeting held
  - b) Education Subcommittee P. Malagrifa reported on the meeting held March 16, 2023, he indicated the subcommittee reviewed provider applications and held a discussion of online prelicensure education, the committee agreed to return the matter to the full Board with a request that the Planning and Research subcommittee take the task of reviewing what online education is allowed by other state boards. The subcommittee tabled the matter of reciprocity with New Hampshire until April in order to collaborate with a committee being formed by the New Hampshire board. The subcommittee intends to meet next on May 3.
  - c) Interpretation Subcommittee No meeting held
  - d) Planning and Research Subcommittee J. Bagni reported that the Subcommittee met on February 28, 2023 to discuss permits, ratios, and the process of exam questions review with PSI, which will be occurring in the next couple of months. He reported that the subcommittee had referred the issue of Reciprocity with NH back to the Education Subcommittee, which it was noted, will now go back to Planning and Research.

#### 6) Discussed Correspondence

- a) Joseph Bednarik, Smart Green Solar requesting the Board facilitate a standardized permit and inspection process for solar installations.
- b) Joseph Bednarik, Smart Green Solar requesting an amendment to MGL 143 3L

Mr. Bagni noted that these requests were seeking a statutory change which was outside the Board's purview. He did note some of the requests had merit, but the Board could not act on them. Members noted in discussion that some of the problems involved concerns with the role of the Inspector of Wires in approving projects and whether they are being asked to approve things outside of their purview.

No formal action taken.

- 7) **Discuss** Reciprocity Agreement with the State of New Hampshire It was noted that this was a placeholder. The chair noted that the next step of the review would be the planning and research committee seeing what other states are doing.
- 8) Discussed other matters not reasonably anticipated 48 hours in advance of the meeting
  - B. Driscoll reported to the Board that there is a Somerville city ordinance that requires permit applicants sign an affidavit of wage payment compliance. He indicated that there was concern that Somerville can't require additional information with a permit. Counsel noted that the matter would need to be referred to the Board of Fire Prevention Regulations if no appeal was filed.

- The chair opened the meeting to public attendee Beverly Kennedy who inquired as to when the examination would be updated based on the new code, staff will review.

#### 9) Board of Electricians' Appeals [open hearings, closed deliberations per M.G.L c. 30A, §18]

10:52 A.M. The Chair opened the Board of Appeals and verified the timeliness and merits of the appeal.

- a) BEA-23-0000002 Smart Green Solar v John Cain, Inspector of Wires, Town Marlboro The matter was taken out of order because both parties for the first matter were not present.
  - The parties in this matter reported that they have resolved the matter and just wanted the Board's opinion, counsel noted that the Board would generally not issue rulings in such case a case, therefore the parties withdrew the appeal.
- b) BEA-23-0000001 Martin Julien v Wisler Louifaite, Inspector of Wires, City of Boston The Chair swore in the parties giving testimony, accepted the exhibits, and gave each party an opportunity to present their position. The Board did not engage in deliberation during the open session. The hearing concluded at 11:21 A.M. J. Bagni made a motion J. Colleary seconded, and the members present unanimously voted to close the hearing and deliberate in quasi-judicial session. The Chair advised the parties that the written decision would be disseminated within 45 days. The Chair announced that as the remaining agenda items would be in closed session, the Board did not anticipate returning to open session, but the Board would adjourn upon conclusion of the Investigative Conference.
