J. Colleary reported on the inspection process. He stated that some towns are requiring remote inspections only and requested that the Board issue an advisory regarding acceptable inspections. Counsel added that in so doing the Board must remain consistent, as the applicable statute has not been waived and, absent an act by the Governor, would apply with equal force during and after the state of emergency. J. Bagni voiced concern regarding the timely conducting of inspections.

A motion was made by J. Colleary and seconded by J. Bagni and so unanimously voted to issue an advisory to Inspectors that virtual inspections are not considered full inspections under the applicable laws and to remind them to perform their inspections within the timelines required by law.

7. Discussion regarding a June 3, 2020 communication from Matrix North American Construction, LLC requesting extension of requirement per 237 CMR 16.03 (3) Business procuring a licensee of record to continue operations.
