6) **Discussed** Report on BFPR/BSEE Workgroup Meeting held February 23.

- The chair indicated that the workgroup finalized a guidance memo and added that the workgroup will continue discussions on the subjects of *mutual aid* and *timeliness*

- The Executive Director reviewed the document with the members and confirmed that it has been issued through the BFPR but will also be posted via the Board's website shortly after the meeting. J. Bagni further indicated the memorandum will also be distributed through MAVA. Finally, Legal Counsel spoke to the Board regarding the impact of this memorandum on the Board. He noted that the Board will not be voting on that memorandum and noted that in the

event there is an appeal of an inspector's decision, that while such a memorandum may be persuasive, it is not binding. The Board would continue to be legally obligated to consider matters on a case-by-case basis based on the actual text of the code and applicable statutes.

- J. Bagni indicated that the Board still has some follow-up regarding the reciprocity agreement with New Hampshire as discussions were not finalized as to how New Hampshire would address documenting licensees interested in reciprocity who have obtained education via an online program allowed by New Hampshire but not Massachusetts. The item will be placed on the March agenda for further review.
