- a) Regulation\CMR Subcommittee No meeting held
- b) Education Subcommittee D. Edmonds stated the subcommittee is scheduled to meet October 2 at 10 A.M. and requested the agenda topics: Provider Application streamlining for NEC 2026 and update on vocational school inspections.
- c) Interpretation Subcommittee No meeting held
- d) Planning and Research Subcommittee No meeting held

#### 6) Correspondence

- a) Carmen Dello Iacono re: Pre-Fab & Co-Op Ed
  - Mr. DellaIacono addressed the Board requesting that the Board collaborate with DESE to discuss prefabrication as part of Co-op Education.
  - David Edmonds explained that the Co-Op program is meant to cover the breadth of electrical experience gained in field work, and that DESE charges the vocational schools with making determinations relative to which employment programs meet with their standard of work within said curriculum
  - J. Bagni answered questions from members on students removed from Pre-Fab Co-Op; as well as explaining that hours signed off from Co-Op must be accrued while in a statutorily-mandated 1:1 ratio. He also referred to Board's previous discussions in 2019 on issues related to Pre-Fab Co-Op ratios not being adhered to, and a potential drafting of an Advisory.
  - The Board took it under advisement and considered updating the exam work experience form 272 with reference to the rule on ratios.
- b) Stephen C. McCarthy re: Utility meter replacements without easements on private property J. Bagni made a motion, and it was seconded by B. Driscoll, and the members present unanimously

VOTED: to refer the matter to the Interpretation subcommittee.

- 7) **Discussed** Formation of workgroup to examine hybrid pre-licensure education J. Bagni made a motion, and it was seconded by D. Edmonds, and the members present unanimously VOTED: to form an ad hoc workgroup consisting of G. Graham, D. Edmonds, C. Caceda, B. Driscoll, J. Bagni and B. Proctor as alternate to determine a policy on hybrid pre-licensure education.
- 8) Reviewed/Discussed Reinstatement petition for Edmond Pela (52301-EL-B)
  - Presented by Counsel C. Kilb (Counsel Chan recused)
- J. Bagni made a motion, and it was seconded by D. Edmonds, and the members present unanimously VOTED: to accept the petition for reinstatement.
- 9) **Board of Electricians' Appeals** [open hearings, closed deliberations per M.G.L c. 30A, §18] 11:00 A.M. The Chair opened the Board of Appeals and verified the timeliness and merits of the appeal.
  - a) BEA-24-000004 Anthony Priego v. Shaun Smith, Inspector of Wires, City of Lynn
    - The Chair swore in the parties giving testimony, accepted the exhibits, and gave each party an opportunity to present their position. The parties came to an agreement to proceed with the hearing. The Board did not engage in deliberation during the open session and took no further action. The hearing concluded at 11:28 A.M. The Chair advised the parties that a letter confirming the outcome would be disseminated to both parties.
  - b) BEA-24-000005 Jesus Cruz v. Darrell Sweeny, Inspector of Wires, Town of Gardner
    - The Chair swore in the parties giving testimony, accepted the exhibits, and gave each party an opportunity to present their position. The parties came to an agreement to proceed with the hearing. The Board did not engage in deliberation during the open session and took no further action. The hearing concluded at 11:45A.M. The Chair advised the parties that a letter confirming the outcome would be disseminated to both parties.
  - c) BEA-24-000006 Barry Ewing v. Christopher Sheehan, Inspector of Wires, City of Brockton
    - The Chair swore in the parties giving testimony, accepted the exhibits, and gave each party an opportunity to present their position. The parties informed the Board that they have resolved the matter but are seeking a precedent decision from the Board. The Chair advised the parties that the Board is unable to issue a decision in a resolved matter. The hearing was closed at 12:32 P.M.
- 10) **Discussed** other matters not reasonably anticipated 48 hours in advance of the meeting.
  - The Executive Director mentioned he will add the matter of holiday lighting to the October agenda.
  - The Executive Director presented a request from Kirk Nussey for the Board to grant an extension beyond the provisions of 237 CMR 16.03 (4) to allow the licensee to pass the Master exam.
  - J. Bagni made a motion, and it was seconded by G. Graham, and the members present unanimously VOTED: to deny the request beyond the allowances of 237 CMR 16.03(4).
