1. The meeting was called to order by the Chair at 10:00 A.M.

- **1. Review** Minutes of the meeting May 10, 2023 and September 18, 2023 P. Malagrifa made a motion B. Driscoll, seconded and it was so unanimously VOTED: to approve the minutes as presented.
- 2. **Discussed** Exam Review Panel update.
 - J. Bagni stated that the Panel has worked on streamlining the questions bank to eliminate questions that were used for both license types and implement more license type specific questions.
 - The Executive Director mentioned the CIB with updates reflecting the number of questions, battery storage and solar questions and eliminating redundancies and other pertinent updates is live via the Board's website and will take effect February 1, 2024.
- 3. Discussed update on draft of advisory pertaining to practices, within statutes & regulations.

- **4.** Reviewed/Discussed current Mass.gov FAQs page with potential questions to be added.
 - The subcommittee members discussed adding and expanding content on the subjects of Journeyman business restrictions, responsibilities of employers to provide work experience verification forms, Business License process and logistics, electrical engineering education and advertising.
- P. Malagrifa made a motion B. Driscoll, seconded and it was so unanimously VOTED: to forward the subcommittee's recommendations to the full Board for approval.
- **5. Discussed** other matters not reasonably anticipated 48 hours in advance of the meeting.
 - The Executive Director mentioned that based on the current exam applicants there are not many who apply from Maine however reciprocity may be worth investigating due to the proximity of the states.
