Introduction

The Massachusetts Registry of Motor Vehicles (RMV) Electronic Vehicle Registration (EVR) Program provides participating Permit Holders and Service Providers with the ability to process certain transactions on behalf of their customers. For more information, review the <u>EVR</u> Program Details.

Overview

The Surviving Spouse transaction is available as an EVR transaction for insurance agents/agencies only.

By <u>Law</u>, a Surviving Spouse legally inherits a private passenger motor vehicle titled in Massachusetts from his/her deceased spouse, unless otherwise specified in a will. The inherited vehicle's registration will remain active until the date specified on such registration. In most cases, the Surviving Spouse may transfer ownership of the vehicle to themselves, retain the same plate, and does not need to pay tax, title, or registration fees. There are certain conditions and rules that are outlined below associated with this transaction. Note that the Surviving Spouse transaction also supports the circumstance where the Surviving Spouse is seeking to title the vehicle in their name without registering it.

Surviving Spouse

To qualify as a Surviving Spouse, the customer (new registrant) must have been married to the deceased person at the time of death. Live-in companions and ex-spouses do not qualify.

Registration Status

The vehicle registration must be active in order to process the Surviving Spouse transaction. In addition:

- If the registration is expired, it may be renewed once in the deceased spouse's name before transferring to surviving spouse
- If the registration is suspended or revoked, the reason for the suspension or revocation must be resolved prior to processing the Surviving Spouse transaction.
- If the registration has any non-renewal actions, they must be addressed prior to processing the Surviving Spouse transaction.

Applicable Registrations/Restricted Registrations

In general, most private passenger registrations are eligible to be transferred to the Surviving Spouse. A list of all of the applicable plates for EVR can be found in <u>Appendix B</u>. Commercial Plates are **not** allowed as part of a Surviving Spouse transaction.

Plates that **cannot** be transferred to a Surviving Spouse:

- Disability
- Medical Doctor (MD)
- Disabled Veterans
- National Guard
- Governor's Council
- News Photographer
- Ham Operator

- US Senate/Senate
- House/House Members
- US Congress
- Honorary Consular Corps

In these instances, the person can still process the Surviving Spouse transaction providing new passenger plates are assigned and the fees paid for the new registration.

Plates Subject to Specific Conditions and Fees

A Surviving Spouse can transfer a Veterans' Bronze Star, Purple Heart, Pearl Harbor Survivor, Silver Star, Distinguished Flying Cross, Congressional Medal of Honor, or Legion of Valor registration plate to him/herself until remarriage, cancellation, or non-renewal, but must pay the initial registration fee* of up to \$100 and the renewal fee* of up to \$100.

***NOTE:** Registration and renewal fees charged are pro-rated, based on the transfer date and renewal month/year.

If the Deceased is a Veteran that never obtained these plates or cancelled them, the Surviving Spouse is eligible to obtain a new set of plates until remarriage, cancellation, or non-renewal.

A Surviving Spouse can transfer an Ex-POW plate (until remarriage, cancellation, or nonrenewal) for no fee. A Surviving Spouse can transfer a Gold Star plate only if he/she is the parent of the deceased.

Title Status Required in order to Process a Surviving Spouse Transaction

- The deceased spouse's title must be a Massachusetts-issued title.
- The deceased spouse's title must be active.
- The deceased spouse's title must not have any active liens.

Required Documents

All Surviving Spouse transactions require the following documents:

- Decedent's Title, signed on the back and assigned to the Surviving Spouse.
 NOTE: The Title is required to process the Surviving Spouse transaction.
- Completed <u>Registration and Title Application (RTA Form</u>), on which the Surviving Spouse is listed as the sole owner. If the vehicle is being registered, the RTA must be stamped by an authorized agent of the insurance company.
- Affidavit of Surviving Spouse Form (this can be signed electronically).
- Death Certificate which lists the name of the deceased spouse (a photocopy is acceptable).

Surviving Spouse Transaction Process

Follow the steps below to process a Surviving Spouse transaction.

- 1. Search and find the Surviving Spouse (sic proposed owner).
 - If the owner/registrant is found, retain the ATLAS Entity Key(s).
- 2. Search for the specific vehicle. If the vehicle is found, retain the ATLAS Vehicle Key. If not found, the Surviving Spouse transaction cannot be processed.
- 3. Select the Surviving Spouse transaction.
- **4.** Build the Surviving Spouse transaction using stored Keys. This reflects the step in the transaction flow where the Service Provider constructs the Surviving Spouse transaction using the following Keys:
 - Vehicle: the Vehicle Key.
 - **Previous Title:** The previous Title Key for a vehicle that was previously Titled on ATLAS.
 - **Title Brands:** If applicable.
 - **Ownership:** The Ownership Key that reflects the proposed owner of the vehicle.
 - **Options:** Select one of the following Registration Options:
 - **Option 1:** Surviving Spouse retains the deceased owner's vehicle using the same registration plate.
 - **Option 2:** Surviving Spouse retains the vehicle and transfers their own plate onto the vehicle.
 - **Option 3:** Surviving Spouse retains the vehicle and chooses to be registered with a new plate.
 - **Option 4:** Surviving Spouse retains only the vehicle and applies for a Title Only.
- 5. The RMV will validate the information as submitted and if everything validates, return a Validated Transaction Key to the Service Provider. The Service Provider must retain this Key to finalize the Surviving Spouse transaction. If there are problems or issues with the validation, the RMV will return one-to-many errors.

6. Document Scanning:

- **a.** Tag and scan the previous Title.
- b. Tag and scan the Registration and Title Application (RTA Form).
- **c.** Tag and scan the Death Certificate of the deceased spouse.
- d. Tag and scan the Affidavit of Surviving Spouse.
- e. Tag and scan all other supporting documents as Other.
- 7. Process the Surviving Spouse transaction and collect the applicable fee(s).
- 8. Print the RMV Fee Receipt and Certificate of Registration to provide to the customer.
- 9. The Surviving Spouse process is complete.
