• Death Certificates

The Board reviewed a request regarding the use of provisional death certificates to determine the release of preneed funds. The Board stated that it is not able to determine the appropriateness of whether a non-certified death certificate would suffice to trigger the release of preneed funeral contract proceeds to an identified licensed funeral home. The Board noted that it is the fiduciary responsibility between the trust maker and beneficiaries in such matters and that the Board does not have authority over this aspect of the financial arrangement of a pre-need funeral contracts. The Board instructed counsel to respond to the query.

The Board stressed that funeral registrants should follow the guidance from Governor Baker's emergency order and safety protocol in providing funeral services and safety measures.
