Call to Order:

Mr. Brezniak moved to call the meeting to order at 10:12 a.m. and Mr. Gormley seconded. Board staff reviewed building evacuation procedures and noted the location of restrooms.

Report from Executive Director, Thomas Burke:

- Mr. Burke announced that as of July 17, 2022, the Executive Office of Administration and Finance increased the mileage reimbursement rate to \$.62 per mile. He reminded Board members to use the updated Excel spreadsheet version of the reimbursement form for any travel incurred on or after July 17, 2022. All forms must be submitted electronically to Board staff for processing.
- Mr. Burke requested guidance from the Board on processing wall certificates for funeral
 establishments and registrants. After discussion, Mr. Brezniak moved to authorize the
 Board chair to be the signatory for all Board-related wall certificates. Mr. Gormley

After discussion, Mr. Brezniak moved to accept the Executive Director's Report. Ms. Leombruno seconded. Motion passed by a roll call vote: Mr. Phaneuf: "Yes.", Mr. Driscoll: "Yes.", Mr. Brezniak: "Yes.", Mr. Gormley: "Yes.", Ms. Leombruno: "Yes".

Report from Board Counsel, Peter Kelley:

Mr. Kelley reported that the COVID Extension bill, S. 2985 ("An Act Relative to Extending Certain State of Emergency Accommodations") was signed by the Governor and is now in effect. The bill extends certain COVID-19 related measures until March 31, 2023, including allowing public bodies to hold its meetings remotely under the open meeting law. In response to Mr. Kelley's report, the Board instructed staff to convene subsequent Board meetings remotely.

Discussion:

• Incoming Executive Director, Jason Wentworth

Thomas Burke formally welcomed Jason Wentworth as the new Executive Director for the Board of Registration of Embalming and Funeral Directing. Mr. Wentworth is the former assistant Commissioner for the Massachusetts Department of Agricultural Resources (MDAR) and has spent time working with the state legislature.

• Executive Order No. 600: Protecting Access to Reproductive Health Care Services in the Commonwealth

Attorney Kelley advised the Board that Governor Baker's recent Executive Order prohibits any executive department, employee, or officer from expending resources in an out-of-state investigation of a licensed Massachusetts professional seeking reproductive healthcare services in that jurisdiction. Further, the Board may not deny or prohibit licensure to any licensed professional seeking reproductive healthcare services in any other state that imposes civil or criminal liability. Board advised that the agency will be implementing proposed policies for Board's future consideration.

• Preneed Reports 2021 – Update

Mr. Burke reported that as of July 15, 2022, Board staff has received all but 34 missing preneed reports for fiscal year 2021. After discussion, the Board instructed staff to send the name and establishment numbers of the 34 funeral establishments to the Board Investigator to follow up. The Board instructed staff to report the names of funeral establishments who do not comply at a subsequent Board meeting and cross-reference with establishments who failed to report for fiscal year 2020. The Board instructed staff to review ways to improve submission of reports through interactive portable document format and electronic reporting.

• Protocol for Closing for Funeral Establishments

Mr. Burke reminded the Board that the protocol for closing funeral establishments is set forth in 239 CMR § 3.04(6) and § 4.03(1). The Board acknowledged that according to § 4.03(1), funeral directors "shall send written notice of any proposed cessation of the funeral establishment's operation to the Buyer (and Beneficiary, if different) of each Pre-need Funeral Contract, via certified mail, return receipt requested, at least ten days prior to the effective date of that proposed cessation of operations."

After discussion, Mr. Brezniak moved to require funeral director to submit to the Board copies of letters sent pursuant to 239 Code Mass. Regs. § 4.03(1) to holders of Preneed funeral contracts and written notification of closing of the establishment within ten calendar days upon closure. Mr. Gormley seconded. Motion passed by a roll call vote: Mr. Phaneuf: "Yes.", Mr. Driscoll: "Yes.", Mr. Brezniak: "Yes.", Mr. Gormley: "Yes.", Ms. Leombruno: "Yes".

Open session for topics not reasonably anticipated 48 hours in advance of meeting:

Ms. Patti Muldoon of the Consumers Funeral Alliance of Eastern Massachusetts inquired
whether closed disciplinary action may be accessed on the Board website to ensure
transparency for consumers. Board staff responded that all closed disciplinary action is
accessible to the public by means of public records request. Board staff noted that
consumers may access evidence of current and past discipline via the "Check a
Commonwealth Licensee" feature on the Board website.

Closed Session: Investigatory Conferences, pursuant to G.L. c. 112, §65C.

At 12:04 p.m., Mr. Brezniak moved to exit open session and enter into closed session to conduct investigatory conferences, pursuant to G.L. c. 112, §65C. Ms. Leombruno seconded the motion. Motion passed by a roll call vote: Mr. Phaneuf: "Yes.", Mr. Driscoll: "Yes.", Mr. Brezniak: "Yes.", Mr. Gormley: "Yes.", Ms. Leombruno: "Yes".
