### **BOARD DECISION**

#### **Procedural History**

This decision addresses a Complaint before the Architectural Access Board (the “Board”) regarding the Emerald Square Mall in North Attleboro, which is owned by the Emerald Square Mall Realty Holding LLC ( “Respondent”). The Complaint alleged that the building is in violation of 521 CMR 28 (Elevators) because no elevators at this location were in working order.

On January 10, 2025, the Board received a complaint that all passenger elevators were shut down at the above-referenced address. On March 12, 2025, a First Notice of Violation was sent to all parties. The Board received no response from the Respondent. On May 19, 2025, a Second Notice of Violation was sent to all parties. Again, the Respondent did not communicate with the Board. On June 4, 2025, a Notice of Hearing was sent to all parties.

A hearing was held on September 22, 2025, in accordance with G.L. c. 30A, §§ 10 and 11; 801 CMR 1.02 *et seq.*; and 521 CMR 4.00.<sup>1</sup> Neither Complainant nor Respondent attended. William Joyce, Executive Director for the Board, appeared and testified. The witness was sworn in by the Board Chair. The instant decision now memorializes the determinations made at that time.

## **Applicable Laws & Regulations**

521 CMR 2.6 requires: At all times, accessibility features must be maintained and fully operational. (i.e. access aisles kept clear at all times, mechanical devices be kept in operating condition, etc.).

521 CMR 28.1 requires: “In all multi-story buildings and facilities, each level including mezzanines, shall be served by a passenger elevator. If more than one elevator is provided, each passenger elevator shall comply with 521 CMR 28. Accessible elevators shall be on an accessible route and located within the space with which it is intended to serve.”

## **Factual Findings**

The following findings of fact and conclusions of law are supported by substantial evidence, based on the credited testimony of the witnesses, documents admitted into evidence, and the Board’s records. G.L. c. 30A, § 11(2), § 14(7).

- 1) On March 12, 2025, the Board served notice on Respondent of reported violations related to the elevators at this location. Ex. 1, AAB 23.
- 2) The Board followed up with a second notice of violation and a notice of hearing, but never received any communication from Respondent. Hearing testimony.

## **Discussion**

The Board’s jurisdiction is established pursuant to 521 CMR 2.6: “521 CMR 2.6 requires: At all times, accessibility features must be maintained and fully operational. (i.e. access aisles kept clear at all times, mechanical devices be kept in operating condition, etc.).”

Mr. Joyce explained after the Complaint was filed with the Board in January 2025, the Board served a first and second notice on Respondent indicating that the lack of elevator service at this location appeared to violate the Board’s regulations. Those notices directed Respondent to provide the Board with Respondent’s plan for achieving compliance. The Respondent did not provide proof to the Board that it had rectified the noncompliance or had a viable plan to do so, and so the Board scheduled this hearing. Respondent failed to attend the hearing, and accordingly continued in its failure to establish that a compliant elevator now exists at this location.

The Board has now considered all of the documents and testimony submitted as part of the hearing, and the Board’s decision is reflected below. The Board finds that Respondent

failed to respond to the Board's correspondence, failed to appear at hearing, and that violations of Board regulations occurred at this location. The Board also notes that failure to comply with the Board's regulations can result in fines of up to \$1,000 per day.

## **Conclusion and Order**

In light of all of the foregoing, the Board votes as follows:


- to ***FIND*** that violations of 521 CMR 28 (elevators) occurred at this location;
