John Viola brought to the attention of the Bureau members that there is new legislation pending, HB-4172, submitted by the plumbers, which would capture medical gases and vacuum piping systems, which would be overseen by Professional Licensure, pointing out that he is not sure how this would fit with Bureau regulations. Leo Fahey pointed out that there is possible conflict of medical gas language with the pipefitting regulation language. The Chairman clarified that the BCCC (Building Code Coordinating Council) meets regularly to review proposed regulation for possible conflict.
