1. At 9:03 A.M. Associate Deputy Commissioner Colleen Maloney announced the opening of the meeting, that there was a quorum present. She provided notice that pursuant to M.G.L. Ch. 30A, § 20, the meeting would be



recorded.

2. Chair took a safety moment and requested members make a note of checking their cars, specifically tire pressure. Additionally, the Chair took a moment to recognize Ron Willey, and inquired about his seat. Acting Executive Director stated we do not have an update yet. The Chair also asked about Emeritus status for Ron, and how to allow for a recommendation to NCEES that Ron should be voted in.
3. At 9:06 A.M. Ron Willey moved, seconded by Nancy Gould to open the meeting. The Motion passed, with a vote of 6-0. Members in Favor: Nancy Gould, Joyce Hastings, Dan Caron, Paul Tyrell, Ron Willey and Ed Englander. Members opposed: None. Members abstaining: Paul Tsang, Ken Anderson, Azu Etoniru.
4. Chair recognized Mr. Lala who was petitioning for reinstatement. Mr. Lala provided an overview of his past discipline, and the Board asked clarifying questions. Chairman expressed concern regarding the applicants understanding of the Boards statutes and regulations. Nancy Gould and Azu Etoniru echoed the Chair's concerns and stated his responses lacked an acceptance of responsibility regarding his past discipline. Ed Englander motioned to go into Quasi Judicial at the end of the meeting, seconded by Ken Anderson. The Motion passed unanimously, with a vote of 9-0. 6. Executive Director report: Chairman noted the Agency has hired a new Executive Director. Cameron Lease, Executive Director, provided an overview of his background. Acting Executive Director Colleen Maloney provided an overview of NCEES exchange. Chair inquired about attendance at NCEES, and when the disclosures are due. Acting Executive Director will circulate disclosures to the members.
7. Ken Anderson moved to approve applications, seconded by Nancy Gould. Motion passed unanimously, with a vote of 9-0.
