





Massachusetts Environmental Policy Act (MEPA) Top 5 Current EJ Initiatives:

- Implement directives of the 2021 climate legislation (St. 2021, c. 8), including requiring "environmental impact reports" (EIRs) for projects proposed near EJ neighborhoods
- Maintain a list of community-based organizations (CBOs) and tribes/indigenous organizations for purposes of facilitating public involvement in project reviews
- Provide guidance to project proponents on community engagement strategies, including language services (in consultation with EEA EJ staff)
- ▶ Develop trainings and outreach to EJ communities to educate the public on ways to participate in the MEPA process (in consultation with EEA EJ staff)
- Improve internal MEPA operations, including site visit procedures and language services

Some ways the definition of EJ population impacts MEPA's work

- Determines the level of MEPA review required for a wide variety of public and private projects
- Informs the types of community engagement strategies that may be appropriate, depending on the nature of the project and its impacts
- Affects the nature of language services provided during project reviews

Department of Agricultural Resources (MDAR) Top 5 Current EJ Initiatives:

- Improving Language Access
 - Internal translation/interpretation requests -- complete
 - External translation/interpretation requests -- ongoing
- Meaningful involvement of community-based organizations through engagement and outreach
- Disseminating information on MDAR grants and programs
- Increasing web-based training and education
- Environmental Justice Internship

Some ways the definition of EJ population impacts MDAR'S work

- Definition of EJ Population appears on all MDAR RFRs
- Referenced in EJ Map Viewer
- Leveraging Definition to Conduct Gap Analysis

Some ways the definition of EJ population impacts MassDEP's work

- ► Ensure all MassDEP staff are aware of the 2021 EJ population and that they are proceeding appropriately community engagement, public involvement, translation services, when appropriate, etc.
- ► Ensure that MassDEP is looking through the EJ lens when conducting key agency actions/activities. Engaging with EJ populations is <u>always</u> intentional and deliberate.
 - Aware of EJ Populations that meet the EJ criteria (minority, income, English isolation)
- ► Ensure resources are available/accessible to MassDEP staff, EJ maps, EJ training, EJ resource site hiring an EJ Outreach Coordinator to assist MassDEP's EJ office.

Department of Public Utilities' Top 5 Current EJ Initiatives:

- Opened an inquiry to examine procedural enhancements to our public notice requirements to increase awareness of and participation in Department proceedings, D.P.U. 21-50
- Established an EJ Team and EJ Point-of-Contact
- Directed the distribution companies to procure language access services for translation of notices and simultaneous interpretation at hearings in certain cases
- More plain language in our Notices
- Contracted with a language access service provider to provide interpretation services for incoming calls from non-English speaking members of the public

Some ways the definition of EJ population impacts DPU's work

- Community engagement with distribution companies or competitive suppliers
- DPU engagement with ratepayers about Department proceedings and public hearings
- Public comment hearings
- Addressing EJ and equity of utility company proposals in certain proceedings
- Addressing EJ and equity issues regarding rideshare company practices and services



Top 5 Current EJ Initiatives:

Accelerating Clean Transportation for All (ACT4ALL)

Equity-focused pilot project grants of up to \$500K - \$1M to increase clean transportation access and decrease existing transportation burdens.

EmPower

Grants of up to \$150K to explore, develop, and implement programs that provide access to the benefits of clean energy for previously underserved populations.

Minority and Women Owned Business Enterprise (MWBE) Support

Grants for programming to support expansion of MWBE in climate critical fields.

Equity Workforce Training Grants

Up to \$1M grants for workforce training of residents of Environmental Justice neighborhoods. Option for \$50K planning grant.

Internship Program: Support Even More Diversity

Provides extra recruiting, placement support, and career training for underrepresented populations.





MassCEC's Environmental Justice Framework

MassCEC is committed to incorporating principles of diversity, equity, inclusion, and environmental justice in all aspects of our work in order to promote the equitable distribution of the health and economic benefits of clean energy and support a diverse and inclusive clean energy industry.

Key Strategies:

- Integrate EJ principles and prioritize EJ populations in grantmaking
 - ▶ EJ-specific programs, EJ selection criteria, reduced or zero match requirements
 - ► Track spending and number of projects in EJ populations
- Build relationships with EJ stakeholders and community groups through regular engagement
 - Convene capacity-building workshops and events
 - Provide capacity-building and planning grants

Municipal Vulnerability Preparedness (MVP) Current EJ Initiatives:

- MVP Action Grants
 - ► EJ Scoring Criteria
 - Letters of support
 - Community Liaison Model
- MVP Planning Grant 2.0
- ► EJ Toolkit
- Designated Equity & Engagement Technical Assistance Regional Coordinator

Some ways the definition of EJ population impacts MVP's work

- Rural EJ community members are not captured in the current EJ definition because rural communities tend not to have "neighborhoods"
- Climate Vulnerable Populations
 - "Climate Vulnerable Populations are those who have lower adaptive capacity or higher exposure and sensitivity to climate hazards like flooding or heat stress due to factors such as access to transportation, income level, disability, racial inequity, health status, or age."
- Challenges for municipalities who use the EJ viewer to determine if they have an EJ block group and if they don't, then just move on without further conversation

EJ Council's Comprehensive Analysis of Definition of "Environmental Justice Population":

Work of the EJ Council

required by An Act Creating a Next Generation Roadmap for MA Climate Policy

-advise and provide recommendations to the secretary of energy and environmental affairs on relevant policies and standards to achieve the environmental justice principles.
- conduct a comprehensive analysis every 5 years to ensure the definition of environmental justice population achieves the objectives of the environmental justice principles.
 As part of the analysis, said council shall provide advice and make recommendations to the secretary on any necessary changes to the percentage thresholds included in this definition and any related regulation.

EJ Population Definition Comprehensive Analysis: Current MA Definition

- "Neighborhood" a census block group as defined by the United States Census Bureau.
- "Environmental justice population" a neighborhood that meets 1 or more of the following criteria:
 - i. the annual median household income is not more than 65 per cent of the statewide annual median household income;
 - ii. minorities comprise 40 per cent or more of the population;
 - iii. 25 per cent or more of households lack English language proficiency; or
 - iv. minorities comprise 25 per cent or more of the population and the annual median household income of the municipality in which the neighborhood is located does not exceed 150 per cent of the statewide annual median household income.
- Exemptions: people who live in college dormitories and people who are under formally authorized, supervised care or custody, including federal, state or county prisons.
