RE: Re-point of Wireless 9-1-1 Calls

The State 911 Department is sending this memo to alert you to a change in how wireless 9-1-1 calls are routed for emergency service number (ESN) 601 currently answered by the Framingham State Police wireless PSAP. ESN 601 is a geographic area comprised of 69 towns in Essex, Middlesex and Suffolk counties and was created specifically for routing of wireless 9-1-1 calls. This change will occur in two phases. Phase one will occur on October 15, 2013 when the State 911 Department directs Verizon to re-point approximately 40% of the call volume for ESN 601 from Framingham State Police to the newly created Essex Wireless Center located at the Essex County Sheriff's headquarters in Middleton. This will include calls from AT&T, Metro PCS and Sprint. Approximately one to two weeks from that initial re-point, the State 911 Department will direct Verizon to re-point the remainder of those wireless calls (T-Mobile and Verizon) from Framingham State Police to the Essex Wireless Center as part of phase two. During the transition period between phase one and phase two, you may need to contact both Framingham State Police and Essex Wireless Center if you require further information on a particular 9-1-1 call or for recording requests.

Wireless 9-1-1 calls initiated on either side of the border of ESN 601 may be answered at either Framingham State Police or the Essex Wireless Center depending on the tower that picks up the 9-1-1 call.
