1. The inmate population was 1004 at the time of inspection.

- 2. During the kitchen inspection the CSP observed:
 - a. Date marking discrepancies on refrigerated time/temperature control for safety food prepared on site. To ensure all time/temperature control for safety foods are consumed or discarded within the time frames stated in FC 3-501.17, the CSP recommended all staff be re-trained on the facility's date marking procedures; and
 - b. Excessive condensation on the lids of time/temperature control for safety foods prepared on site. CSP discussed proper cooling techniques and recommended staff develop procedures to ensure time/temperature control for safety foods are cooled within the allotted time frame stated in FC 3-501.14 Cooling.

This facility does not comply with the Department's Regulations cited above.
