CONSENT AGREEMENT FOR REPRIMAND

The Massachusetts Board of Registration in Pharmacy ("Board") and Ethos Veterinary Health ("Pharmacy" or "Licensee"), a pharmacy licensed by the Board, DS90035, do hereby stipulate and agree that the following information shall be entered into and become a permanent part of the Pharmacy's record maintained by the Board:

- The Pharmacy acknowledges the Board opened a Complaint against its Massachusetts pharmacy license related to the conduct set forth in Paragraph 2, identified as Docket Number PHA-2017-0202 ("Complaint").
- The Board and the Pharmacy acknowledge and agree that on or about October 18, 2017, Board investigators conducted an inspection at the Pharmacy and observed deficiencies including but not limited to:
 - a. Failure to report June 2017 above action level environmental monitoring results, in violation of 247 CMR 6.15(7).
 - b. Failure to remediate above action level environmental monitoring result in the buffer room in June 2017, in violation of USP <797> and 247 CMR 9.01(3).
 - c. Failure to maintain current power of attorney, in violation of 247 CMR 9.01(1) and 21 CFR 1305.05(a). Specifically the power of attorney for former Manager of Record, Justin McDowell, was not revoked and current Manager of Record, Lynn McCarthy, did not have power of attorney.
 - d. Failure to maintain records pertaining to reverse distribution and/or disposal of controlled substances, in violation of 247 CMR 9.01(1) and 1304.21(a).

- 8. The Pharmacy acknowledges that after the Effective Date, the Agreement constitutes a pail lice record of disciplinary action by the Board subject to the Commonwealth of Massachusetts' Public Records Law, M.G.L. c. 4, § 7. The Board may forward a copy of this Agreement to other licensing boards, law enforcement entities, and other individuals or entities as required or permitted by law.
- The Pharmacy understands and agrees that entering into this Agreement is a voluntary and final act and not subject to reconsideration, appeal or judicial review.
- 10. The individual signing this Agreement certifies that he/she is authorized to enter into this Agreement on behalf of the Pharmacy, and that he/she has read this Agreement.
