MEMORANDUM AND ORDER ON LICENSEE'S REQUEST FOR RECONSIDERATION

M.C. R.C. INC. D/B/A CHAMPIONS 234-236 MAIN ST. **EVERETT, MA 02149**

M.C. R.C. Inc. d/b/a Champions (the "Licensee") holds an all alcoholic beverages license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, March 11, 2014, regarding an alleged violation of M.G.L. c.138 §15A Transfer of the Privilege of a license without proper approval.

By decision dated June 18, 2014, the Commission found the licensee in violation of the charge and INDEFINITELY SUSPENDED the license EFFECTIVE FORTHWITH. Commission held that it would not issue any further order without a written request for a hearing from the Licensee to show good cause exists to reconsider the indefinite suspension, and a hearing before the Commission that the Licensee attends.

Good cause for the Commission to consider issuing a further written order revising the order of indefinite suspensions will include, but not be limited to, the Licensee filing with both the Commission and the Local Board the appropriate application to transfer the stock, change the officers and directors, a change of manager, and that appropriate application is granted by the Local Licensing Authorities and approved by the Commission.

By letter dated June 19, 2014, the counsel for the Licensee requested a hearing to reconsider the indefinite suspension. On Tuesday, June 24, 2014, a hearing for the motion for reconsideration was held.

The licensee attended the hearing before the Commission and argued that good cause exists to reconsider the indefinite suspension. The Licensee submitted a complete application which was approved by the Commission on this date. The Commission is satisfied that all appropriate actions have been taken by the Licensee.

Based on the evidence, the Commission reconsiders and reverses its prior order of INDEFINITE SUSPENSION of the license of M.C. R.C. Inc. d/b/a Champions effective forthwith.
