- Merrimack Valley Disaster Report
  - P. Vigneau to report from the B.F.P.R. Restoration efforts took a turn a month ago.
    - P. Kennedy, Town of Andover IOW (Public), The state took over plumbing. Columbia Gas is now repairing appliances rather then replacing them to speed up recovery of service. Approximately 85% complete with restoration but municipal inspectors are still behind.
    - J. Colleary, Have the towns requested mutual aid?
    - P. Vigneau, They are working on getting mutual aid now.

A. Alfonso to report from the B.S.E.E. – We had some problems with out of state plumbers doing electrical work but this issue seems to have been remedied and Niscourse is only permitting electrical work to be performed by licensed electricians.

10:24AM License Renewals start May 1<sup>st</sup>, 2019 – License holders can renew on line as of May 1<sup>st</sup> if they had previously created and account and linked their license. Also all continuing education certificates must be submitted by Provider(s).

# **Mandatory program in Massachusetts**

A Hot Work Safety Certificate for all persons engaged in hot work operations on the work

Site becomes mandatory state-wide in Massachusetts starting July 1, 2018.

What is Hot Work? (527 CMR Chapter 41)

Hot work is any activity or process that involves open flames or that generates sparks or heat and includes: Welding and allied processes; heat treating; grinding; thawing pipes; powder-driven fasteners; hot riveting; torch-applied roofing; and any similar applications producing or using sparks, flame or heat.

#### Discussion:

Can this training be included in 6 Hour professional development classes?

Is this a one-time training?

Applications for Reciprocity Licenses will have to include Hot Works Training.

Will licenses holders be required to carry certification cards with them?

How do Providers get certified to train?

- D. Edmonds, Questions that the Education Subcommittee had merited returning to full board.
- J. Bagni, suggested that we should add training to 6 hour professional development.
- 11:28AM C. Kilb, 15 hour CE is board approved curricula. Professional Development classes are not board approved.
- J. Bagni, De we only do one and done training?
- P. Vigneau, Code is written that training is one and done.
- J. Bagni, One and done is plenty.
- J. Sloan, not everyone on job site needs this certification.
- C. Kilb, BSEE has to specifically approve training.
- J. Colleary, Do we need to add this to C.M.R.?
- C. Kilb, Do we want to make this an optional training?
- 11:31AM P. Malagrifa, Was legislation passed that mandated all electricians to take training?
- P. Vigneau, Courses that state fire marshal has approved.
- J. Bagni, It can go through 6 hour training.
- J. Colleary, Smaller companies will never weld or create sparks.
- J. Bagni, This may not pertain to electricians.
- C. Kilb, Option #1 Do nothing. Electricians who want to do work will need to get training through NFPA.

Option #2 Change the regulations to allow hot works to be done through 6 hour professional development, the change needed because the BSEE does not have the same approval authority over professional development curriculums that it does for the 15 hour course.

Option #3 Mandate that training is done through 15 hours CE.

- D. Edmonds, If we take Option #1 does it put it back on electricians to get certification on their own?
- G. Condon, We should give the electricians the exemption.
- J. Bagni, the board can give this certification.
- K. Guinee, We can watch the plumbers power point video.

Chair Motioned to take a 10 minute recess to get plumbers power point for board. All in favor

# 11:50AM Board Reconvened

C. Kilb, Presented the Power Point to full board. Power Point was written by Wayne Thomas the former ED for the Plumbing Board. Plumbing Providers are trained on the use of the power point.

Stacey Chisholm, Peterson School (Public), This is taught in session 9 of plumbing CE.

- P. Vigneau, The B.F.P.R. and N.F.P.A. recognize that there is not enough welding for electricians.
- K. Guinee, What do we want to do?
- C. Kilb, Does not want to volunteer anyone but someone from the board should take the class.
- D. Edmonds, Motioned for J. Bagni to take the course.

Second by P. Malagrifa

#### Discussion:

Bob Venuti (Public), This is a mandate now, what is the training for electricians now?

- P. Vigneau, No Extension. We need to get some training now.
- P. Malagrifa, Electricians are in violation now if working without training.
- J. Bagni, We need to send notice to electricians.
- 12:03PM J. Bagni, The board cannot train 38,000 electricians
- P. Malagrifa, BSEE needs to mandate advisory. We need to demonstrate that delivery is effective.
- J. Colleary, Presentation from plumbing board was excellent.

Bev Kennedy (Public) Is this a one and done deal? Where do they get training after 2020? Plumbers incorporated into their 550 hour apprentice course.

- T. Cunningham, Power Driven fasteners are grinding and falls into "Hot Works". It is covered by electrical permit.
- 12:10PM Stacey Chisholm (Public), The Subcommittee members said that this training could be incorporated into 6 hour class. Provider 322 (Public), 3 hour class for certification per the NFPA training can work on all trades.

Motion by P. Malagrifa for staff to issue advisory to A, B, C & D license holders, advising them if they are going to be working in "Hot Works" then must receive certification. Advisory can go out without returning to board for approval.

C. Kilb cautioned to not endorse NFPA as there are non-NFPA providers as well.

Second by J. Colleary. All in Favor.

#### **Revision Energy Prototype Discussion:**

- E. Dorian, Board should allow for some on line training. Proposes that the board allow 30% of 600 hour education can be completed on-line.
- J. Sloan, The board should first start with allowing "make-up" classes to be completed on-line and see if this would work.
- P. Malagrifa, Conquered that moving full 600 hours is too much too soon but some on-line education should be considered.
- 11:13AM D. Edmonds, On-line courses may open the door to cheating. In person education is valuable for the trades.

Motion to turn down Revision Energy and others like by D. Edmonds Second by J. Bagni

#### **Discussion**:

- T. Cunningham, This is an interactive trade.
- J. Bagni, Said that he is in schools all day, it is an apprenticeship school and education and work go hand in hand. With the failure rate at 50% now, it may be higher if classes done on line. J. Bagni opposed to any on-line classes. J. Colleary, this cannot be determined in one meeting.
- 10:18AM E. Dorian, We think of on-line training as not being interactive but on-line training can have video conferences, there are fail safes for on-line courses. If there is another No vote the board will not look at it for another year. We should have a discussion group.
- C. Kilb, Another trade (plumbing) does allow for video conferencing. The instructor sees every student on screen. The benefit is that plumbing gets to say that they do allow on-line.
- J. Bagni, Understood that we were going to deny Revision Energy. Motioned to deny application. Second by P. Malagriffa. Unanimous vote
- D. Edmonds made a motion that no reciprocity licenses for NH applicants with education received from Revision Energy or the like. J. Bagni seconded the motion
- 11:24AM C. Kilb, Can we table discussion and vote until next meeting to get information on the effect this would have on the reciprocity agreement.
