A motion was made by J. Bagni to approve the list as presented. The motion was seconded by P. Malagrifa. Unanimously approved.

- **5. Review** the most recent examination passage/failure report This report was not available by the time of meeting. Tabled by unanimous consent.
- **6. Review/Discuss** other reports:
 - a. Office of Investigations

Board's legal counsel Charles Kilb reported that efforts are continuing to hire a new compliance officer, no further information is available at this time. No formal action required.

b. Legal Counsel

Board's legal counsel Charles Kilb reported that the draft amendments to 237 CMR 13.00 have been approved for a public hearing and asked the Board if the December meeting would be an acceptable date. The members noted that as scheduled, the meeting would take place on the 23rd in a holiday week. The members discussed moving the meeting to December 16th instead. A motion was made by J. Bagni to move the meeting to December 16th assuming space is available. The motion was seconded by D. Edmonds. Unanimously approved.

- c. Board of Fire Prevention Regulations Paul Vigneau reported to the Board.
 - i. Mr. Vigneau reported that the latest edition of 527 CMR 1.00, the Massachusetts Comprehensive Fire Safety Code is now in effect.
 - ii. Proposed amendments to 527 CMR 12.00, the Massachusetts Electrical Code, are now scheduled for a public hearing on December 5 in Stow. It was noted that there are outstanding issues that DFS will be working with DPL to resolve.
- d. Legislative matters

Board's legal counsel Charles Kilb indicated that there was nothing to report.

7. **Discuss** subcommittee meetings and reports:

- a. Regulation\CMR Subcommittee J. Colleary indicated that there was nothing to report.
- b. Education Subcommittee D. Edmonds reported on the education subcommittee meeting October 25. The subcommittee reviewed 57 applications, approved 44, and rejected 13. The next meeting is tentatively scheduled for November 8 if there are more applications to review. The members indicated that a clarification on the bond requirement was made, noting that it is required by all applicants and must be attached to the application. Ellen Dorian indicated that she was resigning as alternate on the subcommittee due to a scheduling issue. A motion was made by D. Edmonds to nominate J. Bagni to serve as the new alternate. The motion was seconded by J. Colleary. Unanimously approved.
- c. Interpretation Subcommittee E. Dorian indicated that there was nothing to report. She noted that previously the subcommittee discussed possibly meeting with the Department of Public Utilities. The matter will be placed on a future full Board agenda.
- d. Planning and Research Subcommittee K. Guinee indicated that there was nothing to report.

8. Discuss other matters not reasonably anticipated 48 hours in advance of meeting.

a. D. Edmonds reported that sophomores from the Benjamin Franklin School of Technology attending the Board meeting. By unanimous consent, the Board members

allowed the students to address the Board with any questions. A student inquired as to how interpretations of the electrical code works. P. Vigneau explained the role of the Board of Fire Prevention Regulations in drafting the electrical code, C. Kilb explained the role of the Board of Electricians' Appeals in issuing decisions based on the language in the code.

b. J. Bagni inquired as to the process governing the approval of six hour inspector classes. A motion was made by J. Bagni to refer the matter to the Education Subcommittee. The motion was seconded by D. Edmonds. Unanimously approved.

9. Board of Electricians' Appeals [hearings open, deliberations closed per M.G.L c. 30A, §18]

A motion was made by P. Malagrifa to convene the Board of Electricians' Appeals. This motion was seconded by J. Colleary. Unanimously approved.

Docket No. 299, BEA-19-000008 In the matter of Michael Trimarchi vs Sarah Andrade, City of Cambridge

Inspector Sarah Andrade appeared as well as appellants Matthew Richard and Michael Trimarchi. After entering into exhibits, the Board allowed each party to present their case, which involved a job in Cambridge which was failed due to alleged insufficient labeling.

At 11:38 a.m., the parties rested. Thereafter, P. Vigneau made a motion to close the hearing and deliberate. This motion was seconded by J. Bagni.

The Board returned to Open Session at 12:08 p.m.

A motion was made by J. Bagni to reverse the Inspector's decision and issue a written decision. This motion was seconded by D. Edmonds. The chair called for a vote: 8 in favor, 2 opposed. Thereafter, the Chair notified the parties that a written decision would be issued within 45 days.

10. Executive Session (M.G.L. c. 30A, §21 – Closed session)

At 12:13 p.m., a motion was made to enter Executive Session to discuss individuals character rather than competence and to discuss pending litigation by D. Edmonds. This motion was seconded by J. Bagni.
