2.	Asset Management Planning (AMP) Grant Extension Requests: Mr. O'Keefe stated that ar					
	AMP Grant extension request was received for Franklin CWA-23-04. The community noted					
	that they have faced delays to the project. It was recommended that the community be granted					
	an extension of 60 days beyond the requested extension deadline.					
	The Executive Committee voted unanimously to give an extension through 12/30/2025 to allow					
	the community ample time to complete the scope of work and project closeout documentation.					

2. Lead Service Line (LSL) Planning Grant Extension Requests: Ms. Omole stated that LSL Planning Grant extension requests were received from three communities, as outlined in the Executive Materials. West Newbury noted they are working with their engineers to develop a plan to determine which locations require further investigation. Holyoke Water Works requested an extension to continue data collections and update the inventory as necessary. Whitinsville Water Company reported that they are working with their engineers on LSL identification and notification activities. It was recommended that the communities be granted an extension of 60 days beyond the respective extension deadlines requested.

The Executive Committee voted unanimously to grant the recommended deadline extensions to allow the communities ample time to complete the scope of work and project closeout documentation.



MassDEP Water-Smart Program Testing for Lead In Drinking Water in Schools and Early Education and Care Facilities

MassDEP's Water-Smart Program

- Goal: provide free technical assistance and testing for lead
- Offered to all eligible public and private schools/childcare facilities that have not previously tested through the program
- MassDEP has been running a lead testing program since 2016
- One round of comprehensive testing at all fixtures used for drinking/cooking/health
- Have tested 285 schools and 882 childcare facilities since 2020
- Immense effort involving many partners including UMass Amherst which implements the program

Next Phase: Remediation Reimbursement

- EPA now allows grant funds to be used for remediation
 - Do Not Drink Stickers
 - Investigatory Sampling
 - Filters: Counter-top, faucet-mounted and under-sink
 - Aerator, Fixture, Premise Plumbing, and LSL/GRR Replacement
- Plan to Pilot Remediation Reimbursement Program January 1st
 - Using \$100k of EPA WIIN grant funds
 - Eligible: Schools/EECFs in communities with children ID as high-risk of lead poisoning who tested and found lead
 - Priorities include locations with flush samples above 15 ppb
 - Submit receipts and testing results for reimbursement up to certain amounts

Requests

- Reimbursement check issuing
 - Can the Trust issue reimbursement checks to individuals/private entities like private schools, childcare centers, family programs?
 - Similar to cybersecurity grant process but maybe higher number of checks and smaller amounts
- Private school testing funds
 - In 2021, Trust agreed to provide \$400k to cover private school testing (which EPA grant funds cannot be used for).
 - Approximately \$235k of those funds remain.
 - Private school engagement has been particularly challenging
 - Can we get approval to expand use to include remediation reimbursement?
 - Would fill current gap in our proposed program
