Executive Summary

The Trial Court's case flow metrics reflect key components of the Court's mission -- justice with dignity and speed. The metrics encourage transparency and accountability in the management of Trial Court operations. This report presents a year-over-year comparison of the Trial Court's key case flow metrics and reflects changes in its operations as it emerged from the pandemic.

- Fiscal Year 2023 marked the first full year since the pandemic without restrictions on Trial Court operations and staffing.
- Case flow metrics for FY 2023 reflect a major effort by all departments to prioritize backlogged cases and decrease the size of the pending caseload, which peaked in FY 2021 as a result of the pandemic.
- Early in the pandemic, reduced numbers of metric case filings allowed courts to pivot and shift focus onto the pending caseload. From FY 2021 to FY 2023, the case backlog declined by 144,872 or 31.9 percent.
- Metric case filings increased 4.8% over the prior fiscal year to 669,407 cases in FY 2023, as the number of cases disposed or completed increased to 697,616, an 8.1% increase in the same period. Since FY 2021, metric case filings have increased by 16.5% or 94,697 cases, signaling a return to pre-pandemic levels.
- The FY 2023 clearance rate a measure of outgoing cases to incoming cases surpassed 100% for the second consecutive year, which reflects that courts are resolving or disposing of more cases than the number of cases received. This indicates that they are addressing the backlog of aged cases.
- Overall, 362,573 cases, or 69.5% of those subject to time standards, were disposed on a timely basis (within the time standards) in FY 2023, a 6.5% improvement from the prior year. The average rate of growth in the pending caseload dropped by approximately 4,000 cases per month.
- The number of cases pending beyond time standards decreased by 22.1%. Of 309,886 pending cases, 148,087 were pending beyond time standards. At the end of the prior fiscal year, 190,103 cases were pending beyond time standards.
- During FY 2023 more than 1.8 million events were scheduled, of which 68.5% were held. Events may not be held for a variety of reasons, including requests by litigants or agreements to resolution. Our hope with the implementation of this new metric is that it allows for better data collection and insight into best practices for scheduling matters across the Trial Court.



Case Flow Metrics

The Trial Court implemented case flow metrics in 2006 for use by court leaders, staff, and judicial officers to manage court operations with transparency and accountability. The four case flow metrics, adapted from the National Center for State Courts' CourTools, are a set of performance measures used to manage the timely disposition of cases. Timely disposition is determined by time standards which provide benchmarks for assessing performance. Time standards are promulgated through the standing orders of each department.

The Massachusetts courts have continued to refine the use of case flow metrics to assist court leaders and the state is a national leader in the use of court metrics. Case flow metrics are closely intertwined and need to be considered in totality, rather than separately, to accurately understand case flow. The Trial Court's four key case flow metrics are:

Clearance Rate

A measure of outgoing cases to the number of incoming cases. Its purpose is to determine if the court is disposing cases at the same rate as the number of cases filed.

Time to Disposition

The rate of cases disposed or resolved within established time standards. Its purpose is to assess the length of time it takes a court to process cases.

Age of Pending Cases

A measure of active, pending cases that are beyond the disposition date set by the time standards. Its purpose is to assess whether there are delays in case processing.

Event Date Certainty

A measure of court events with recorded outcomes compared to total court events scheduled. An event may not be held by request of a litigant or attorney or by agreement to an informal resolution. Its purpose is to assess the court's capacity to hold case events.

Response to the Impact of the COVID-19 Pandemic on Case Management

In response to the COVID-19 pandemic, the Trial Court implemented a variety of strategies to manage and dispose of its caseload including virtual hearings as an option to attend court hearings and remote services such as e-Notice delivery. The decline in metric case filings early in the pandemic enabled the Trial Court to pivot and prioritize backlogged cases which peaked in FY 2021. From FY 2021 to FY 2023, the case backlog declined by 144,872 or 31.9 percent. In FY 2023 the average rate of pending caseload growth dropped by approximately 4,000 cases per month. The drop in the pending caseload reflects the Trial Court's commitment to timely court operations.








