Area Need Improvement	For two of seven human rights committee meetings held over the past two years, committee composition requirements were not met due to lack of a physician or nurse among its membership. The agency needs to ensure that the Extra Special Teas Human Rights Committee has all the required members.
Process Utilized to correct and review indicator	The nurse previously on the human rights committee was unable to remain on the committee. Extra Special Teas had been looking for a nurse to fill this position to no avail. Upon being informed that our human rights committee was lacking a physician or nurse during the review, we were able to find a physician who was willing to fill the position.
Status at follow-up	A retired physician has agreed to fill this position on our human rights committee. Our next HRC meeting is scheduled next week, February 22, and the physician will be present. Attached are our Bylaws stating that a physician or nurse will be on our committee. The physician representative is also a Board Certified Infectious Disease physician and the parent of one of our participants, thus having experience in the fields of developmental disabilities and/or mental illnesses.
