#### DECISION

RAM KRISHNA HARI CORPORATION DBA SCUTTLEBUTTS LIQUORS 407-409 MAIN STREET FAIRHAVEN, MA 02719 LICENSE#: 89477-PK-0384

HEARD: 7/22/2025

Ram Krishna Hari Corporation d/b/a Scuttlebutts Liquors ("Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission ("Commission" or "ABCC") held a hearing on Tuesday, July 22, 2025, regarding an alleged violation of 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Prior to the commencement of the hearing the Licensee stipulated to the facts alleged in Investigators Kenny and Terasconi's Minimum Purchase Age Compliance Check Field Report.

- 1. Investigators Kenny and Terasconi's Minimum Purchase Age Compliance Check Field Report, 4/28/2025;
- 2. ABCC Application Summary Review, Transfer of License Approved, 1/30/2019;

# **FINDINGS OF FACT**

- 1. On Monday, April 28, 2025, at approximately 5:10 p.m., Investigators Kenny and Terasconi ("Investigators") conducted a compliance check at Ram Krishna Hari Corporation d/b/a Scuttlebutts Liquors.
- 2. An underage operative, working under the supervision of Investigators, purchased alcoholic beverages, one 6-pack of Bud Light beer for eight dollars and seventy-nine cents (\$8.79). The underage operative was not asked for identification.
- 3. The Licensee has held a license under M.G.L. c. 138, § 15 since 2019.

## CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. Ch. 138, § 34 Sale or Delivery of an alcoholic beverage to a person under twenty-one years of age. Therefore, the Commission issues a **WARNING.**
