value and a point will be reached in the near future where a logger will not pay for the value of the red pine but will charge for its removal. At the current rates for that type of tree removal the Commonwealth could pay approximately 1 million dollars to complete the project in Myles Standish State Forest.

 White pine will not be cut in the harvesting project only red pine and Norway spruce will be cut. The Forest Product Harvesting Permit to guide the harvest will specify this with penalties incurred for the cutting of undesignated trees.


## **Green Futures**

Although supportive of the proposed Pine Barrens project but feels that the proposal is lacking in information on other flora and fauna species present and the affect the harvest may have on them, plans to control invasive species, control of illegal ORV use, archeological review.

The Forest Management Proposals offered to the public are intentionally general. They gather and present information available from initial reconnaissance of the site, known data such as Natural Heritage Atlas information and available forest inventory. In the process of public outreach and consultation used by the DCR – BOF the proposal posting is followed by gathering internal comments from the DCR Ecologist, DCR Archeologist, DCR site staff, Division of Fish and Wildlife and comments from the general public. Additionally, a complete forest stand exam/inventory of the specific site is conducted. In the case of the Pine Barrens Project the DCR Ecologist conducted an additional forest structure and species inventory and the DCR Archeologist conducted a site visit to augment initial project review. Per the public outreach policy of the BOF, a detailed silvicultural prescription has been prepared for the Pine Barrens Project as is done for all commercial timber harvests. The prescription integrates comments and data gathered after the Forest Management Proposal and provides most of the information that is noted in the comment to be lacking.

- Considerable consultation regarding the control of invasive species has been conducted during the preparation of the Pine Barrens project and an Invasive Species Control plan is being developed, albeit in the early stages.
- As noted above the DCR Archeologist has conducted a review and the management recommendations for resource protection have been incorporated in the prescription and will be implemented during the harvesting process.
