Funded by the Office of Grants and Research, a state agency that is part of the Executive Office of Public Safety and Security, the Charles E. Shannon Community Safety Initiative (Shannon) is modeled after the Office of Juvenile Justice and Delinquency Prevention's Comprehensive Gang Model. Shannon is a multi-sector approach used to address a community's gang and youth violence problem. Each community receiving Shannon funding demonstrates the presence of risk factors for youth and gang violence. Shannon participants must be between the ages of 10-24 years.

Youth Risk Assessments

12% Youth in danger of engaging in risky LOW-RISK* behavior or gang activity. 53% Youth exposed to the same risk factors MODERATE- as low-risk youth, as well as additional risk factors such as truancy.

35% Youth who are perpetrators or victims of HIGH-RISK* shooting or stabbing violence, and/or are known gang members.

Success Highlight

"In 2023, we processed 20 young people in Youth Court who were given additional services through Shannon funding. Of those 20 youths, 13 have completed Youth Court and have avoided a criminal stain on their record. We saw positive improvements in their behaviors during their case management...Several of these youths were using illegal substances when they came into Youth Court, and by the end of our program, they had clean screens. We engaged one of the 13 youths in a 30-day mental health clinic that allowed them to receive much-needed services. One of our Shannon youths asked for assistance in detoxing from alcohol and getting into recovery services. We were able to help them navigate the recovery world and follow up with them to ensure they were getting all of the assistance out there for them at their age."

Gang Activity in Fall River



Conflict between gangs consists of narcotic sales, turf, girlfriends, or the belief that disrespect has occurred from one gang to the other. The consistent conflict escalates into violent confrontations, revenge shootings, stabbings, home invasions, robberies, beatings, random attacks, spray painting, and firearm possession. Fall River gangs participate in all these activities but also commit other crimes such as domestic violence, rape, motor vehicle theft, and arson. Gangs of Fall River have engaged in sex trafficking crimes, including prostitution and the formation of trafficking rings. Drug and firearm trafficking are the primary sources of profit for gangs. Social media has allowed these groups to create and share videos that glorify the "gang lifestyle" and use them for recruitment. Older gang members recruit juveniles to engage in criminal activity (being a lookout or holding weapons and drugs). The gang unit has observed initial gang involvement/activity beginning at an earlier age than in the past. Officers continue to see the recruitment and exploitation of children as young as ten years old. We have also seen an uptick in a large group of young teens who are branching out and trying to get credibility by creating their own "subsets" within the city.
