Local/Long Distance Rates:

Local moves are charged by the hour and include travel in the following states: NH, VT, MA, ME, RI, CT.

Long distance, outside of New England states, and commercial rates are calculated by cubic feet of the amount of household goods.

Hourly Rates:

Moves will be conducted on a 'straight time' basis, with a minimum hourly charge as set out below plus actual travel time. The clock starts at the appropriate hourly rate when the movers leave the Fast & Quality Moving office location, and includes the movers estimated return time to the office location.

Minimum Cubic Feet Charge:

- The minimum Cubit feet will be between 300 to 400 Cubit feet depending on the area.

Minimum Hourly Charges:

- Two-Hour Minimum (plus travel time and if it exceeds 30 min each way, billed in 15 minute increments)

Charges Include (Local):

- Door to Door Service
- Loading & Unloading
- Labor & Transportation
- Disassembling & Reassembling
- Free use of moving pads to cover and protect your wooden basic furniture
- Extra charge when need storage

Fast Quality Moving

- No Extra Charges for second stop, Tolls, Weekends & Holidays,

Extra Charges (Local):

If you need any items hoisted from a window or porch the price is \$125.00 for the first piece and \$30.00 per flight for the second additional piece.

(Some items may be required to come through a window because they are too large to put through a staircase. Please note that it is a good idea to notify the carrier of this requirement prior to commencement of a move. Please note that

the carrier may make last minute accommodations if we encounter this requirement during a move, at full expense and liability to the customer. Please note that there is a natural risk of damage to real property or the item being hoisted and the client is solely liable for this risk. Hoists require special equipment and 3 movers minimum to service.)

The following charges shall be assessed for overweight items in addition to the hourly rates quoted above in this tariff, in connection with a move involving additional items:

- Pianos - \$170
- Hot Tubs - \$100
- Riding Lawn Mowers - \$170
- Gun Cabinet - \$90
- Pool table -\$250
- Safe over 350 pounds

Elevator or Stair Carry (Local):

Fast & Quality Moving does not charge an additional fee for elevator or stair carry.

Elevator or Stair Carry (Long Distance):

- Elevator: \$75.00
- The first flight of stairs is included, Each additional flight of stairs is \$75.00 (7 steps = 1 flight)
- Long carry: First 75 ft. Free. Each additional 75 ft. \$75.00

Supplemental Fees (Long Distance):

- Shuttle service: \$1.00 per cu.ft. (\$350 minimum)
- Packing of fragile/delicate items (such as TVs, glass, etc.); packing and crating services not already listed within proposal; loading of bulky items (such as a motorcycle).

Fast Quality Moving

- Packing labor and supplies such as boxes, bubble wrap, etc.
- Storage: First 30 days Free, any additional month will be charged at \$0.50 per cu.ft. per month, if payment is not received before a DUE date \$50 late fee will apply, STORAGE RATE CAN NOT BE PRORATED.

Waiting Time:

The customer is charged the rates specified above for all waiting time or delays which are not the fault of Fast & Quality Moving.

Fuel Surcharge:

On the first Monday of each calendar month, the "New England Average" price of diesel fuel will be based on the price stated by the US Department of Energy (DOE), Energy Information Administration's (EIA) survey of "Retail On-Highway Diesel prices". This price will be obtained by calling the DOE fuel hotline at 202-586-6966 or via the DOE Internet web site at www.eia.doe.gov. (<https://www.eia.gov/petroleum/gasdiesel/>)

Note: 1: Subject to a minimum Fuel Cost Adjustment charge of \$30.00 per Truck/per day when the DOE Diesel Fuel Price Index is at least \$2.50 per gallon.

Note 2: Notwithstanding any other provisions of the tariff, the Fuel Cost Adjustment Factor WILL APPLY to any charges/trips applicable during the period that the Fuel Cost Adjustment Factor is in effect. It is at the discretion of the Carrier to maintain a surcharge lower than the outlined calculation.

Note 3: The Fuel Cost Adjustment Factor WILL BE SHOWN SEPARATELY from the transportation/moving charges on documents for the purpose of identifying the amount as special fuel related revenue.

Note 4: The Carrier shall explain fully the fuel surcharge to be assessed prior to the move or during the estimate process.

Estimates:

Travel estimates are set ahead of the move.

Fast & Quality Moving is not responsible for any additional costs associated with packing and moving beyond the original estimate. The customer pays actual time.

Parking:

Any associated parking permits are the responsibility of the client. If no permit is obtained, the client takes the responsibility of paying any parking tickets.

Please read the following requirements & regulations to ensure a smooth and worry-free move.

Deposit Requirement (Local):

Fast Quality Moving

Due to the limited nature of the services Fast & Quality Moving provides, Fast & Quality Moving required a deposit in the amount of 1 hour of the regular moving rate or \$100 to hold and secure a specific move date, moving crews and other resources. Please note that this deposit is non-refundable, however it will be applied to the final cost of the move.

Cancellation of Services (Local):

Please note that in the event of a cancellation, Fast & Quality Moving is entitled to the initial deposit placed by the customer. A written notification at least 24 hours in advance that includes the customer's name, address, and scheduled move date and the deposit will be refunded.

Confirming the Move (Local):

Confirmation 24 hours in advance - A confirmation call will be made by our office the afternoon before you move. We will not be able to perform your move without a confirmation call or email from you or a representative of yours.

If our staff cannot reach you via phone the day before your move, your move will be taken off the schedule (for morning arrivals), and re-scheduled after we have spoken with you.

Method of Payment (Local):

Payment in full is expected at the completion of the move. Forms of payment accepted are cash, credit or debit card. Credit or debit cards incur a 5% fee. Only cashier's checks are accepted. NO PERSONAL CHECKS ACCEPTED.

Reschedule/Cancellation Of Services: (Long Distance):

Rescheduling your move date must be submitted in writing, via written notification to sales@fastqualitymoving.com by the customer more than (10) business days prior to the service date, in order to avoid a rescheduling fee of \$200.00.

The carrier has the right to cancel services ordered by the customer at its sole discretion subject to the complete refund of prepaid deposits. EXCEPT: When cancellation is due to a change of order at origin for which the customer refuses to accept the adjusted rates. Customers may cancel services more than (10) business days prior to the originally scheduled move date via written

notification to sales@fastqualitymoving.com Customer must verify that the cancellation notice has been received for a complete refund of prepaid deposits.

If services are canceled 10 business days or less from the originally scheduled move date they may receive a partial refund of their deposit. If services are canceled 7 business days or less from the originally scheduled move date the customer shall forfeit prepaid deposits. Forfeited deposits will be used to pay for expenses incurred due to late notice of cancellation. If cancellation of service by the carrier and or customer occurs at the time of pick up, the customer will be

held liable for the payment of all services rendered per the carrier's applicable tariff and at full tariff rates. **TO FINALIZE THE REQUEST YOU NEED TO CONTACT 857-261-7587.**

I agree to pay the total charges for moving services to be provided by BOSTON MOVER FQM (the "Company"). I understand that my deposit/fee represents only a portion of my total estimated service charges. For scheduling and routing purposes, my deposit/fee is not refundable, unless I notify the Company in writing by sending an email to sales@fastqualitymoving.com and call **857-261-7587** of my intent to cancel the estimate, change my pick up date, or place the move on hold, more than (10) business days (Saturday, Sundays and Holidays not included) prior to the pack or load day (whichever comes first) listed above. I understand that if I cancel my move 7 business days or less prior to the scheduled pack or load date and the truck has not arrived at the pick-up location then I am only entitled to receive a credit of my deposit for future interstate moving services to be used by the cardholder within a 12-month period from the date of cancellation. If I cancel my move seven (7) business days or less prior to the scheduled pick-up or load date and the truck has arrived to attempt services, then I am not entitled to a refund or a credit of my deposit/fee. All credit card refunds will be processed on my next billing statement.

Method Of Payment (Long Distance): 35% is required at the time of reservation of service paid by all Certified Checks, Money Orders, Zelle, and All major Credit/Debit cards EXCEPT AMEX. At origin, 60% of the balance must be paid by all Certified Checks, Money Orders, Cash, Zelle, Wire Transfer, or online payments via Credit/Debit card (a convenience fee of 5% will be applied). The

remaining balance must be paid in full prior to offloading the truck at the destination by Money Order from (Postal office), Zelle, Wire transfer, or Cash ONLY. The carrier reserves the right to collect 15% of all charges due in addition to the 100% of a binding estimate or 110% of a non-binding estimate if impracticable operations are required at the time of delivery. *We will not accept any checks if there are less than seven (7) business days between the pickup date and the delivery date.

*If the customer is ready for delivery immediately, no checks will be accepted on pick up. The remaining balance must be paid in full prior to the unloading of the truck at the destination (before unloading your shipment) by CASH or POSTAL MONEY ORDER only. Please note: if payment is returned to us as NSF (non-sufficient funds), the first month's storage will apply to your total charges,

a fee of \$50 for the NSF (non-sufficient funds) will be necessary and full payment for the total contracted amount will be required prior to delivery.

Packing Your Goods (Long Distance): All Customers are responsible to pack all boxes and fragile items (glass, mirror, marble, and electronics) unless noted

differently on this Estimate Cost For Service. If the full packing service was not selected, packing materials (such as bubble wrap, boxes, tape, shrink wrap, mattress covers, glass crates, TV crates, etc.) are an extra cost. Packing materials will be charged solely based on what will be used for your move and

according to the packing materials order form. On the Full Professional Packing service, packing materials and labor for the Cu .Ft. over the estimate will be charged according to the full BOSTON MOVERS FQM tariff (\$1.70 per cu.ft. under 500 cu.ft and \$1.25 over 500 cu. ft.) *specialty items a la cart (vintage, antiques, or pieces of similar likeness). For health and sanitary reasons all mattresses, box springs, and futon pads must be properly protected in a mattress box or plastic cover. Personal effects in plastic bags are not allowed in the truck. *Note*: Packing supplies are not included in the transportation cost and will be charged if required.

Packing Services and Dis-assembly (Local):

Fast & Quality Moving does not charge an additional fee for packing; the regular hourly rate applies. Additional costs include market price of packing materials, including sales tax on the materials, as listed below.

Fast Quality Moving

In general, Fast & Quality Moving expects everything that can be boxed, should be boxed. The carrier can not take loose items.

Storage:

You can get a quote from your sales associate. If you need overnight hold on the truck we charge up to \$150.00 per night.

We charge by the hourly rate for the time to unload at storage and reload when you are ready for delivery.

Insurance:

Basic Insurance of \$0.60 per pound up to \$50 per item.

Extra Insurance:

Fast & Quality Moving is a licensed and insured mover. Fast & Quality Moving does not provide insurance to the customer. In the event of an accident, carrier liability is limited to the shipper declaration of value of shipment on the bill of lading. Shippers must secure their own insurance.

****Fast & Quality Moving is only responsible for items in our immediate care, custody and control. Therefore, we are not responsible for damage to items**

coming out of storage, items from your truck, or items you packed into boxes yourself. You will be asked to sign a Release of Liability acknowledging this.

Customer's Declaration of Value:

THIS IS A TARIFF LEVEL OF CARRIER LIABILITY – IT IS NOT INSURANCE

You must select by placing your initials next to one of the following two options for your shipment prior to the start of any packing or moving service. The option you select and declaration you make establishes Carrier's liability for your Property.

OPTION A:

RELEASED VALUE OF \$0.60 PER POUND PER ARTICLE. If an article is lost, destroyed or damaged while in Carrier's custody, Carrier's liability will be limited to the actual weight in pounds of the lost, destroyed or damaged article times

\$0.60, regardless of the actual value of the article. Option A is the basic liability level and is provided at no additional charge.

DECLARED VALUATION PROTECTION OF \$_____. Subject to Damage Claims above and Section 6 below, if an article is lost, destroyed or damaged while in Carrier's custody, Carrier will, at its option, either i) repair the article to the extent necessary to restore it to the same condition it was tendered for delivery to Carrier, or pay you for the cost of such repair; or ii) replace the article with an article of like kind and quality, or pay you the actual cash value of such replace item. In either case, because the Property is used and not new, the agreed replacement value for any item is based on its depreciated value and Carrier's maximum liability shall not exceed the depreciated value or \$3.50 per pound per article lost or damaged, whichever is greater. To select this option, a stated value must be declared as the agreed value by you, on the line above, a lump sum value of your

shipment that may not be less than \$3,500 or \$3.50 per pound multiplied by the actual or constructive weight of the shipment, in pounds, whichever is greater. The cost – your valuation charge – for such additional protection is \$4.00 per \$1,000 of valuation you declare. Your valuation charge for the value you declare for this option is \$_____.

I understand in a situation of a complete loss of shipment, Carrier's legal liability will be limited to no more than the declared value above and the shipment loss will be covered at the valuation I selected. Maximum amount of protection available is \$100,000 per truck load. If you need more than this, you must make arrangements with the office no later than 3 days before your move date. Special provision regarding articles of extraordinary value (value in excess of \$100 per pound per article). As further limited by Carrier's Tariff and Section 5 below, articles such as jewelry, watches, precious stones, rare or antique artwork, collectable items or other items in excess of \$100 per pound per article will not be accepted for shipment unless this special provision is completed both by you and Carrier. If you fail to identify to Carrier in writing that this shipment contains any such articles of extraordinary value by completing in full the provision below, the shipment will be deemed released to

Carrier without any such items and as such, Carrier shall assume no liability for loss or damage to those articles. Further limiting Carrier's liability, for any articles of extraordinary value listed, the Carrier's maximum liability for loss or damage is limited to \$5,000 for any one loss, disaster or occurrence.
