Findings of Competing Provider Effective Competition Following December 8, 2015 Filing Deadline for Existing Franchise Authority Recertification

MB Docket No. 15-53

On June 3, 2015, the Commission released *Amendment to the Commission's Rules Concerning Effective Competition; Implementation of Section 111 of the STELA Reauthorization Act*, which revised the Commission's rules related to Effective Competition.¹ The statute permits a franchising authority to regulate basic cable service tier rates and equipment only if the Commission finds that the cable system is not subject to Effective Competition.² A franchising authority that wants to regulate a cable operator's basic service tier rates and equipment must first become certified by filing FCC Form 328.³ The *Effective Competition Order* adopted a presumption that cable operators are subject to one type of Effective Competition, which is commonly referred to as Competing Provider Effective Competition.⁴ As a result of the presumption of Competing Provider Effective Competition, the *Effective Competition Order* also directed franchising authorities with existing certifications that wish to remain certified to file revised Form 328, including an attachment rebutting the presumption of Competing Provider Effective Competition, within 90 days of the effective date of the new rules.⁵ The new Effective Competition rules

became effective on September 9, 2015, and franchising authorities seeking to remain certified thus were required to file revised Form 328 by December 8, 2015.⁶

Pursuant to the *Effective Competition Order*, if a franchising authority with an existing certification does not file revised Form 328 by the deadline, its existing certification will expire on the filing deadline as long as there is not pending for the franchise area an opposed Effective Competition petition or an opposed or unopposed petition for reconsideration of certification, petition for reconsideration of an Effective Competition decision, or application for review of an Effective Competition decision.⁷ The *Effective Competition Order* directed the Media Bureau to issue a public notice at the conclusion of the 90-day timeframe identifying all franchising authorities that file a revised Form 328 as well as those franchising authorities that are party to one of the above-listed proceedings, and stating its finding of Competing Provider Effective Competition applicable to all other currently certified franchising authorities.⁸ The *Effective Competition Order* also directed the Media Bureau to issue a public notice at the conclusion of the 90-day timeframe granting all pending unopposed cable operator Effective Competition petitions where the franchising authority has not filed revised Form 328.⁹ Accordingly, we issue this Public Notice to fulfill these requirements.

In Appendix A, attached hereto, we identify the franchising authorities that filed revised Form 328 by the December 8, 2015 deadline. In Appendix B, attached hereto, we identify pending opposed Effective Competition petitions. In Appendix C, attached hereto, we identify the one pending petition for reconsideration of certification. In Appendix D, attached hereto, we identify pending petitions for reconsideration of an Effective Competition decision. And in Appendix E, attached hereto, we identify pending applications for review of an Effective Competition decision. With regard to the Community Unit Identification Numbers (“CUIDs”) of currently certified franchising authorities that are not listed in Appendix A and are not subject to any of the pending proceedings listed in Appendices B through E, we find that Competing Provider Effective Competition is present. This finding is based on the current presumption of Competing Provider Effective Competition, as supported by the analysis in the *Effective Competition Order*, as well as the franchising authorities’ failure to attempt to retain their certifications by resubmitting Form 328 accompanied by the requisite showing of no Competing Provider Effective Competition.¹⁰ As set forth in the *Effective Competition Order*, existing certifications for franchising authorities and CUIDs not subject to one of the forms or proceedings listed on Appendices A through E thus expired as of December 8, 2015.¹¹

With regard to the franchising authorities that filed revised Form 328 by the December 8, 2015 deadline, as listed in Appendix A, their certifications will remain valid unless and until the Media Bureau issues a decision denying the new certification request.¹² If a franchising authority listed in Appendix A

also is subject to a pending cable operator Effective Competition petition, petition for reconsideration of certification, petition for reconsideration of an Effective Competition decision, or application for review of an Effective Competition applicable to the franchise area, then the Media Bureau will consider the record from that filing along with the new certification in making its determination regarding whether the franchising authority has overcome the presumption of Competing Provider Effective Competition.¹³ If a pending Effective Competition proceeding is listed in Appendices B through E, but the franchising authority did not file revised Form 328 by the deadline, then the Media Bureau or the Commission will adjudicate the pending proceeding based on the record before it.¹⁴

Finally, Appendix F identifies pending unopposed Effective Competition petitions involving franchise areas for which a timely revised Form 328 was not filed. As required by the *Effective Competition Order*, by this Public Notice we grant the petitions listed in Appendix F based on a finding of Competing Provider Effective Competition.¹⁵ That finding is based on the current presumption of Competing Provider Effective Competition, as supported by the analysis in the *Effective Competition Order*, as well as the franchising authorities' failure to oppose the cable operator Effective Competition petition in the first instance.¹⁶

This Public Notice is issued pursuant to the *Effective Competition Order* and in accordance with Section 0.283 of the Commission's rules, 47 C.F.R. § 0.283.
