* **FLA-B** published Federal rate is the same as other SLAs, however, to reduce the benefit rate for in-kind support and maintenance, SSA increases the net countable unearned income in the SDX file by \$304.66 for individuals and \$228.50 for each member of an eligible couple (2023 amounts). Rates shown above are reduced by that amount and are the rates used to determine the cash benefits. This approach and the reduction amount are determined by SSA.

** **FLA-D**: The full federal payment amount is used to determine Medicaid eligibility; however, the lesser amount (Federal rate of \$30 [2023] + State rate of \$42.80) is used to determine the cash SSP benefit.
