

Re: Request for Prior Approval for "Equipment" Expenditure

Dear Mr. Staton:

The Department of Public Health (MDPH), the Lead Agency is currently updating its state database ("equipment") and is requesting prior approval for \$1,184,599. This will be used for the ongoing development and maintenance of the system. Per OMB guidance, prior approval is needed as: "Equipment" is defined in the OMB Uniform guidance in 2 C.F.R § 200.33 as an article of tangible personal property (including information technology systems) having a useful life of more than one year and a per-unit acquisition cost which equals or exceeds the lesser of the capitalization level established by the non-Federal entity for financial statement purposes, or \$5,000.

The Lead Agency continues to upgrade its database by developing the Early Intervention Client system (EICS). The EICS is a web-based application designed to be easily accessible for EIS providers working in the field to assist in documentation of service delivery. Once complete, this database upgrade offers benefits to EIS providers (e.g., elimination of paper forms, elimination of redundant data entry, mitigation of duplicative referrals and enrollments resulting from human error), the Lead Agency (e.g., increased amount and quality of data collected on service indicators), and ultimately, the infants and toddlers receiving the Part C services (e.g., an electronic medical record for each child allows for seamless transition between EIS providers if a family moves, easier access by families to their child's records, increased security and protection of child and family data).

The EICS is a critical component of the Lead Agency's broader data system and serves as the foundation for its General Supervision system. The EICS collects data for SPP/APR Indicators 1,

2, 3, 4, 5, 6, 7, 8, and 11. Access to these data allow the Lead Agency to monitor the services provided to infants and toddlers enrolled in the Commonwealth's Part C system. Additionally, the EICS collects fiscal and claims data, on which the Lead Agency relies to conduct its fiscal monitoring and ensure it serves as the Payor of Last Resort.

The Lead Agency will use this funding to support the ongoing maintenance of the EICS, including hosting costs, help-desk services, and ongoing enhancements identified via stakeholder engagement. The application is FERPA-compliant, and Lead Agency staff conduct periodic audits of the data system logs to ensure access of child records is limited to authorized users.

The Lead Agency followed the policies and procedures established by MDPH and the Comptroller during the procurement and contracting processes, and the EICS is owed by the Commonwealth of Massachusetts and will continue to be used for the foreseeable future. The Comptroller of the Commonwealth has established Fiscal Policies for State Agencies. The Comptroller has broad authority to prescribe accounting rules and instructions for all state Departments and the appropriate use of the state accounting system. Pursuant to G.L. c. 7A, § 7, G.L. c. 7A, § 8, G.L. c. 7A, § 9, G.L. c. 29, § 6B and § 31, the Comptroller is required to implement a state accounting system (including a centralized payroll system) and issue instructions for the accounting practices to be used by all Departments for supplies, materials, assets, liabilities, equity, debt, encumbrances, expenditures, revenues, expenses and obligations of all Commonwealth funds and accounts, including payroll, unless specifically exempted by general or special law. The Comptroller has full authority to prescribe, regulate and make changes in the method of keeping and rendering accounts and is authorized to direct departments to implement changes in their systems to meet these statewide standards. This broad authority covers the application, administration, and disbursement of federal grants. MDPH fiscal procedures mirror Comptroller Policies.

We appreciate your consideration of this request as we continue to increase the quality of our data systems.
