Dear Mr. Sampaio:

Upon a thorough review of the administrative record, I have decided to adopt the Magistrate's finding for the claimant based on the respondent's failure to request a hearing.

Therefore, it is my **Final Decision** that recreational saltwater fishing permit DMF ID #1553241 issued to you is hereby suspended and will not be renewed for a period of three years (2018-2020). You may not apply for, hold or otherwise be issued a recreational saltwater fishing permit until 2021. Any such permit inadvertently or mistakenly issued to you during this time shall be null and void.

You have the right to seek judicial review of my **Final Decision** in the appropriate Superior Court pursuant to G.L. c. 30A, §14(1). The complaint must be filed within thirty days of the delivery date of this decision.

SHOW CAUSE ORDER RESPONDENT'S RIGHT TO REQUEST HEARING

Fabio Sampaio (hereinafter "you" or "respondent") may file a written request for a due process hearing to **SHOW CAUSE** why recreational fishing permit DMF ID #1553241 should not be suspended, revoked or not renewed by the Director of the Division of Marine Fisheries ("MarineFisheries"). Under authority of G.L. c.130, §80, and 322 CMR §7.10(8)(a), the Director is authorized to take such action based on respondent's alleged violations of the Commonwealth's striped bass laws and regulations. The purpose of a due process hearing is to provide respondent with the opportunity to contest these violations as alleged by the Massachusetts Environmental Police. You may have an attorney or other authorized agent represent you at the hearing.

The attached Request for an Adjudicatory Hearing and Law Enforcement Report charges that on or about August 24, 2017, the respondent conspired to violate marine fishery laws and regulations regulation striped bass.

The above charges would constitute the following issues for adjudication at a due process hearing.

- 1. Aid or assist in fishing violations, in violation G.L. c. 130 §1.
- 2. Failed to display fish upon demand to an Environmental Police Officer, in violation of G.L. c 130 §13.
- 3. Possessed striped bass in excess of the recreational fishing limit established at 322 CMR §§6.07(5)(b) and (7)(h).

It is the respondent's responsibility to exercise the right to a due process hearing by filing with the *MarineFisheries* Administrative Law Clerk a written motion or request within twenty-one days of your receipt of this **ORDER**. Failure to file a written request for a hearing in a timely fashion shall constitute a waiver of respondent's right to a hearing and the adjudicatory proceeding will be decided based on the administrative record in this case.

All due process hearings are conducted by an Administrative Law Magistrate in accordance with the relevant due process requirements of G.L. c.30A, §§10, 11, 12 and 14, and the Standard Rules of Adjudicatory Practice and Procedure, 801 CMR §1.00, et seq. Due process hearings are held on Friday afternoons between 1:00 and 5:00 p.m. in the Hearings Room of the Department of Fish and Game, Suite 400, 251 Causeway Street, Boston, MA 02114.

All written correspondence including a request for a hearing, an appearance, an answer, motions, or other pleadings shall be in writing. All pleadings shall be identified by caption and docket number and may be mailed, faxed or sent electronically to the Administrative Law Clerk, Division of Marine Fisheries, 251 Causeway Street, Suite 400, Boston, MA 02114; (T) 617-626-1534; (F) 617-626-1509; <u>Jared Silva@massmail.state.ma.us</u>.

In addition, all pleadings filed with the agency clerk shall be sent to all other parties in this adjudicatory proceeding in accordance with the provisions of 801 CMR §1.01(5)(f).
