SUMMARY OF NO. 25-28

This proposed law would limit the property tax for each parcel of real estate in a given tax year to 102.5% of the property tax assessed for that parcel in the prior tax year.

The proposed law states that, if any of its parts were declared invalid, the other parts would stay in effect.
