#### **About the Office of Economic Empowerment**

The Office of Economic Empowerment (OEE) helps people learn how to confidently manage their money and plan for their family's future. The department is also a resource to organizations, government agencies and elected officials as they work to support their communities' economic well-being. Under the guidance of Treasurer Goldberg, the department also works alongside policymakers to establish pathways to wealth equity in Massachusetts.

OEE has programs for individuals looking to improve their financial literacy. In addition, the department manages BabySteps, which provides a free \$50 deposit into a MEFA U.Fund College 529 Investing Plan account for Massachusetts babies and recently adopted children, helping families save for their children's future education and job training costs.

Their "Financial Wellness 4 All" initiative offers sessions on budgeting, debt management, investing, retirement planning, estate planning, fraud prevention, and strategies for major purchases. Additionally, the "Ballin' On A Budget" program is tailored to assist individuals on the autism spectrum in developing money management skills. The foundation also collaborates with organizations to deliver financial education workshops for employees, promoting better financial health and reduced stress in the workplace.

#### **Action for Boston Community** Development, Inc.

Action for Boston Community Development (ABCD) offers a variety of financial education services to help individuals and families achieve financial stability. Their free VITA tax assistance program, staffed by IRS-certified preparers, helps maximize refunds while promoting savings and debt reduction. The Youth Engaged in Action (YEA!) program provides financial literacy and job readiness training to middle school students, equipping them with essential money management skills early on. Additionally, the SummerWorks program offers paid job experience for youth while teaching financial literacy, career skills, and leadership development. Through these initiatives, ABCD empowers community members to build a stronger financial future.

The Cambridge Economic Opportunity Committee (CEOC) offers financial education workshops and individual coaching to assist Cambridge residents with low and moderate incomes in achieving their financial goals. They also offer tax preparation services. Their services include creating spending plans, initiating emergency savings, developing debt repayment strategies, reviewing and correcting credit reports, and learning to protect against fraud and identity theft. These services are available to all Cambridge residents earning at or below 200% of the Federal Poverty Line.

#### **Jewish Vocational Services (JVS)**

IVS Boston offers free financial education programs designed to help individuals achieve financial stability. These services include one-on-one financial coaching, where clients work with a coach to develop money management skills, create financial plans, and set and achieve financial goals. The coaching relationship typically lasts between 12 to 18 months and includes personalized assessments, credit report reviews, and assistance in creating household spending plans. Additionally, JVS Boston provides financial education workshops covering topics such as budgeting, saving, and credit management.
