C. Old Business – Discuss FCAM Recommendations

General Counsel Steven Rourke drafted another progress memorandum to FCAM outlining DFS' recommendations following the, "FCAM Report and Recommendations Re-credentialing Task Force" to be sent as soon as possible.

The Commission did not request any changes be made to the memorandum.

E. General Issues and Updates from DFS

Deputy Marshal Fournier explained that the Department remains consumed by COVID-19 and that there are several staff members assigned to "COVID Public Safety Testing" either at one of the two testing sites (Springfield and Foxboro) or as call takers/schedulers. Each site is managing up to 200 patients a day.

Marshal Ostroskey explained that there are no recruit programs running at this time but that there are daily discussions on when and how the Department will handle reopening this core function. At this time, there is a waitlist of eight months from when we start up again.

He would like to compliment the entire Department of Fire Services team for stepping up to the tasks and protocols that have been established. Everyone is doing great work under these circumstances.
