Emergency Resource Activation

HAZARDOUS MATERIALS RESPONSE TEAMS

Hazardous Materials Response Teams can be activated to support the fire service in the Commonwealth 24 hours a day, seven days a week.

For immediate response to activate any of the six district Hazardous Materials Response Teams, call 877-385-0822 and follow the appropriate prompts.

Levels of Response

- JHIRT – Joint Hazard Incident Response Team – Contained Suspicious Powder Calls, Assessment of Clandestine Laboratories, and/or Activation of Clandestine Lab Enforcement Team (CLET)
- Tier 1 – Hazardous & Risk Assessment – Suspicious Substances, Open or Loose Suspicious Powders
- Tier 2 – Short Term Operation – Limited Release
- Tier 3 – Long Term Operation – Full Team – Large Release
- Tier 4 – Multi District Response – Multi-Operational Period
- Tier 5 – WMD/Mass Contamination – Full System (6 teams) Response

SPECIAL OPERATIONS

The Department of Fire Services Special Operations team can be activated 24 hours a day, seven days a week.

For immediate response, contact:

MEMA at 508-820-2000

You will be asked for:

- The vehicle(s) needed
- City or town of the incident
- Contact name and number
- Nature of the incident
- Street address (where the vehicle(s) should respond to)

Once a response has been activated, the requesting agency will be contacted with an ETA of the vehicle(s) and directions for the incoming vehicles to the incident.

Resources that can be activated include:

- Incident Support Unit (ISU)
- Rehab Unit
- Incident Support Trailer
- Unmanned Aerial Systems (UAS)/Drone

Emergency Resource Activation

CODE COMPLIANCE & ENFORCEMENT UNIT

The Department of Fire Services Code & Enforcement Unit and Boiler & Pressure Vessel Unit can be activated 24 hours a day, seven days a week.

For immediate response during business hours (8 a.m. - 4 p.m.):

Code Compliance Unit (CCEU) 978-567-3375

Boiler & Pressure Vessel Unit (BPV) 978-567-3780

After business hours for both units 508-820-2000 (MEMA)

Notify the Boiler & Pressure Vessel Unit for incidents involving non-residential boilers and pressure vessels.

Notify the Code Compliance & Enforcement Unit for any of the following incidents:

- Theft of fireworks or explosives (527 CMR 1.00:65)
- Personal injury or property damage from fireworks or explosives (527 CMR 1.00:65)
- Blasting where fly rock occurs (527 CMR 1.00:65)
- Fires where a suppression system failed to operate, such as kitchen hood systems and self-serve gas stations (527 CMR 1.00:50)
- Above Ground Storage Tanks (over 10,000 gallons) leaking, damaged, fire or injury (527 CMR 5.00)

The CCEU and the BPV license and regulate the industries involved with these materials and incidents. The CCEU and BPV units must review all incidents for compliance with appropriate statutes and codes.

Response to Clan Lab Investigations

- Investigations of known or suspected clan labs
- Execution of search warrants at clan labs
- Training personnel to recognize and respond to clan labs
- Special events
