# Environmental Justice Public Involvement Plan (PIP) FirstLight Hydroelectric 401WQC Application Filed with MassDEP

This Environmental Justice Public Involvement Plan ("PIP") identifies outreach and engagement-related responsibilities to be undertaken by the Applicant, FirstLight Power ("FirstLight"), and the Massachusetts Department of Environmental Protection ("MassDEP") to ensure the affected environmental justice ("EJ") population(s) has an adequate opportunity to participate in the public process associated with MassDEP's issuance of a 401 Water Quality Certification ("WQC").

This PIP has been prepared because there are EJ populations in Greenfield and Montague. This matter involves a WQC for the federal relicensing of two hydroelectric plants greater than 10 MW pursuant to 33 U.S.C. § 1341. No EJ population has been identified based on limited English proficiency. (Source: Environmental Justice Populations in Massachusetts)

#### What are FirstLight, FERC, and the FERC license renewal?

FirstLight is an electrical energy producer with a focus on renewable energy, including hydroelectric, pumped hydro storage, solar, large-scale battery, and offshore wind assets. It has offices in Northfield, MA, New Milford, CT, Oshawa, ON, and Montreal, QC with its corporate headquarters in Burlington, MA.

In December 2020, FirstLight filed an Amended Final License Application with the Federal Energy Regulatory Commission ("FERC") to relicense the Connecticut River hydroelectric facilities in Turners Falls and Montague and the pumped storage facility in Northfield (all located in Massachusetts) under the Federal Power Act, 16 U.S.C. § 797(e). These facilities rely upon water flowing through turbines to generate electricity. FirstLight is now operating based upon FERC-issued annual licenses under the terms of the previous licenses that expired on April 30, 2018.

The pumped storage facility in Northfield generates power by pumping water from the river to an upgradient reservoir where it is stored and then released back down to the same location through turbines to generate electricity. It is sometimes referred to as a "giant water battery" because the reservoir water is generally stored and then released later to generate electricity. Sometimes it is released to provide needed electricity when other supplies, like wind or solar power, have intermittent decreases in energy production.

#### What does this FERC license renewal proceeding have to do with MassDEP?

As a part of the federal relicense application filed with FERC, FirstLight must also apply for a WQC from MassDEP. FirstLight is required to file its WQC application with MassDEP within 60 days of FERC issuing a Ready for Environmental Analysis ("REA") notice. FERC issued the REA notice on February 22, 2024. FirstLight is expected to file its WQC application within 60 days, or April 22, 2024. MassDEP will have one year from when FirstLight files its WQC application to issue a WQC.

#### On what information can MassDEP base its WQC?

In the WQC process, MassDEP is obligated to determine whether there is reasonable assurance that the proposed relicensed operations will be conducted in a manner which will not violate Massachusetts Surface Water Quality Standards at 314 CMR 4.00. This determination is based on whether the proposed project will provide the water quality required to protect, maintain, and enhance existing and designated uses.

The Connecticut River is classified in the Massachusetts Surface Water Quality Standards ("SWQS") at 314 CMR 4.00 as an inland Class B Warm Water. Each class of water is identified by the most sensitive water uses to be enhanced, maintained, and protected (the "designated uses"). Existing uses are designated uses and other sensitive uses that have been attained in a waterbody on or after November 28, 1975. Surface waters are protected by the antidegradation provisions specified in 314 CMR 4.04(1), which require that "in all cases existing uses and the level of water quality necessary to protect the existing uses shall be maintained and protected". The Class B designated uses are: (1) habitat for fish, other aquatic life, and wildlife; (2) contact recreation, including both primary (e.g., wading and swimming) and secondary (e.g., fishing (including consumption) and boating; (3) irrigation and other agricultural uses; (4) compatible industrial cooling and process use; and (4) consistently good aesthetic value. (see 314 CMR 4.01-4.02 and 4.05(3)(b).

<u>MassDEP's focus</u>: Given the above standards and the applicable law, MassDEP's WQC will be based on scientifically sound evidence and consideration of related public input concerning how the proposed project will affect the existing and designated uses. It is important to remember that sometimes the uses have conflicting water quality needs that MassDEP must consider. MassDEP must protect the most sensitive use if there is a conflict.

#### What public input has there been to date?

Stakeholder engagement activities conducted by FERC or FirstLight associated with FERC's federal relicensing process (not the WQC) have been ongoing for over 12 years. FERC related public meetings are listed in Appendix A.

FirstLight engaged stakeholders resulting in a Flows and Fish Passage Settlement Agreement and a Recreation Settlement Agreement. Parties to the Flows and Fish Passage Settlement Agreement included: FirstLight, the National Marine Fisheries Service, U.S. Fish and Wildlife Service, Massachusetts Division of Fisheries and Wildlife, Nature Conservancy, American Whitewater, Appalachian Mountain Club, Crabapple Whitewater, Inc., New England FLOW, and Zoar Outdoor. The purpose of the Flows and Fish Passage Settlement Agreement is to resolve, among the signatories, relicensing issues related to fish passage, flows for the fishery, ecological conservation, recreation, and protected, threatened, and endangered species.

The Recreation Settlement Agreement also included a single Recreation Management Plan for the Turners Falls and Northfield Mountain Projects. Signatories to the Recreation Settlement Agreement included FirstLight, National Park Service, Massachusetts Department of Conservation and Recreation, Towns of Erving, Gill, Montague and Northfield, American

Whitewater, Appalachian Mountain Club, Crab Apple Whitewater, Inc., New England FLOW, Zoar Outdoor, Access Fund, Franklin Regional Council of Governments, and Western Massachusetts Climbers Coalition. The purpose of the Recreation Settlement Agreement is to resolve, among the signatories, relicensing issues related to upgraded and new recreation features including improvements to meet Americans with Disabilities Act requirements, new river access points, establishing conservation easements on FirstLight-owned lands and interpretive signage.

These Settlement Agreements are not binding on MassDEP for the WQC; however, during the WQC process MassDEP will consider whether the Settlement Agreements are consistent with its WQC obligations and public input.

In addition to these Settlement Agreements, FirstLight engaged with Tribal stakeholders, including the Elnu Abenaki Tribe, the Chaubunagungamaug Band of Nipmuck Indians, and the Nolumbeka Project, resulting in a signed Memorandum of Understanding in Principle to Develop a Relicensing Settlement Agreement for cultural resource preservation and mitigation efforts.

#### How will the public be able to provide input for the WQC?

There will be several opportunities for public participation during the WQC process. On the initial WQC application, there will be two (daytime and evening) remote public hearings during a thirty-five-day comment period; about midway through the WQC process there will be a hybrid public information session (combined in-person and remote access); and lastly, for the DRAFT WQC which will be approximately eight months into the process, MassDEP is planning two more remote public hearings (daytime and evening) during a comment period of at least 21 days.

In addition, MassDEP will continue to maintain a webpage devoted to this project to provide updates and a forum for the public to submit questions and comments and sign up for periodic email updates. ## What outreach will be provided to stakeholders, including those in Environmental Justice Populations?

Means of notification/publication: FirstLight will inform the public of the above participation opportunities in notices that are *pre-approved* by MassDEP and compliant with applicable EJ requirements and policies. The notices will be published in the Massachusetts Environmental Monitor and in a local or regional newspaper with the largest readership distribution both online and in hardcopy, if hardcopy exists, within the area that may be affected by the project. MassDEP will publish the notices on its website.

FirstLight will also send copies of the notices to the chief municipal elected official and the conservation commission for the municipalities that may be affected. FirstLight will request that those municipalities publish the notices in the local town or city hall and on the website of the community or communities that may be affected. Notice may also be published in other local venues, such as libraries, grocery stores, and houses of worship.

Contents of Notice: The public notice must specify how written comments may be submitted; the expiration date of the public comment period; the date, time, and location of public hearing(s) (or public information session, as applicable), an internet link if the hearing or information session is virtual or hybrid; the applicant's and Department's websites where additional information may be obtained; and notice that translation services will be provided if they are requested by an EJ population. The notice shall also identify the location and the type of project for which the application is filed; and points of contact for information requests to FirstLight and MassDEP.
