DECISION

K.R.B. CORP. INC. DBA LOG CABIN 135 WESTMINSTER ST. FITCHBURG, MA 01420 LICENSE#: 039400057 HEARD 2/28/2012

K.R.B. Corp. Inc. dba Log Cabin (the "Licensee") holds an all alcohol license issued pursuant to M.G.L. c. 138, §12. The Alcoholic Beverages Control Commission (the "Commission") held a hearing on Tuesday, February 28, 2012, regarding an alleged violation of M.G.L. c.138 §23 (3 counts). Prior to the commencement of the hearing, the licensee stipulated to the violations alleged in Investigator Timothy Hooton's Investigative Report.

The following documents and physical items are in evidence as exhibits:

- 1. Licensee's Stipulation of Facts:
- 2. Investigator Hooton's Investigative Report dated September 28, 2011;
- 3. Two (2) bottles of alcoholic beverages; and
- 4. One (1) Receipt from The Country Mile, Rt. 31, Greenville, NH dated September 21, 2011 in the amount of two hundred fifty-six dollars and ninety-seven cents (\$256.97).

There is one (1) audio recording of this hearing.

FACTS

- 1. On Wednesday, September 21, 2011, at approximately 3:45 p. m., Investigators Jamie Binienda and Timothy Hooton investigated the business operation of K.R.B. Corp. Inc. dba Log Cabin to determine the manner in which their business was being conducted.
- 2. Investigators had received a complaint stating that the licensee was buying alcohol from a package store in New Hampshire.
- 3. Investigators conducted an inspection of the bar area and found two (2) bottles with retail package store stickers on them.
- 4. The two (2) bottles taken into evidence were:
 - a) Bacardi Rum, 1.75 liters; and
 - b) Riunite Wine.
- 5. Investigators spoke to the owner, Mr. Brian Keenan, and asked him if he had purchased any alcohol from a package store.

- 6. Mr. Keenan produced a receipt from The Country Mile Store in Greenville, New Hampshire, with alcohol sales totaling two hundred fifty-six dollars and ninety-seven cents (\$256.97).
- 7. Mr. Keenan admitted the alcohol purchased was for the licensed premises.
- 8. Investigators informed Mr. Keenan of the violation, and that a report would be submitted to the Chief Investigator for further action.

CONCLUSION

Based on the evidence, the Commission finds the licensee violated of M.G.L. c.138 §23 (3 counts). The Commission suspends the licensee's license for three (3) days, of which one (1) day will be served, and two (2) days will be held in abeyance for a period of two (2) years provided no further violations of Chapter 138 or Commission Regulations occur.
