DECISION

RIVER STREET LIQUORS INC. D/B/A SULLIVAN'S LIQUORS 363 RIVER STREET FITCHBURG, MA 01420 LICENSE#: 0394-00048

VIOLATION DATE: 06/22/2017 HEARING DATE: 10/24/2017

River Street Liquors Inc. d/b/a Sullivan's Liquors (the "Licensee") holds an alcohol license issued pursuant to M.G.L. c. 138, § 15. The Alcoholic Beverages Control Commission (the "Commission" or "ABCC") held a hearing on Tuesday, October 24, 2017, regarding an alleged violation of 204 CMR 2.05 (2) – Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. Prior to the commencement of the hearing, the Licensee stipulated to the violation alleged in Investigator Doyle's Report.

The following documents are in evidence:

- 1. Investigator Doyle's Compliance Check Field Report; and
- 2. Licensee's Stipulation of Facts.

There is one (1) audio recording of this hearing.

The Commission took Administrative Notice of the Licensee's record.

FACTS

- 1. On Thursday, June 22, 2017, at approximately 6:30 p.m., Investigators Bailey and Doyle ("Investigators") investigated the business operation River Street Liquors Inc. d/b/a Sullivan's Liquors.
- 2. An underage operative, working with Investigators, purchased from the Licensee an alcoholic beverage, a can of Budweiser Light beer for two dollars and thirty-cents (\$2.30). The underage operative was not asked for identification.

CONCLUSION

Based on the evidence, the Commission finds the Licensee violated 204 CMR 2.05 (2) Permitting an illegality on the licensed premises, to wit: M.G.L. c. 138, § 34 – Sale or delivery of an alcoholic beverage to a person under twenty-one (21) years of age. As the Licensee has been in business for more than 10 years with no prior violations, the Commission issues a **WARNING**.
