Instructions for Form DE-1**Registry category 1.** Dedham, Edgartown, Fall River, Nantucket, New Bedford, Plymouth and Taunton.Complete Parts A, B, C and D of Form DE-1. Those subject to collecting Supplemental Deeds Excise, as explained in the schedule below (and in M.G.L. Ch. 61 of the Act of 2009, Section 2) will enter an amount into line 6. Those *not* retaining Supplemental Deeds, leave line 6 blank.**Registry category 2.** Adams, Boston, Cambridge, Fitchburg, Great Barrington, Greenfield, Lawrence, Lowell, Northampton, Pittsfield, Salem, Springfield and Worcester.

Complete Part A, lines 1 through 4 and Part B of Form DE-1.

Registry category 3. Barnstable.

Complete Part A, lines 1 through 4 and Parts B, C and D of Form DE-1.

Schedule of supplemental county deeds excise fund. From line 6 of the Deeds Excise Return.

Per M.G.L. Ch. 61 of the Act of 2009, Section 2, after the targeted amount in the supplemental county deeds excise fund is collected in the fiscal year, no further amounts for the supplemental county deeds excise fund are calculated.

Enter the amount from line 6 in the appropriate line and column below. Calculate and enter the cumulative total.

Fiscal year supplemental county deeds excise fund collections. When the Total Supplemental Deeds Fund Claimed has reached the Total Authorized Supplemental Deeds Fund Amount for fiscal year, do not collect any further supplemental county deeds excise.**Note:** If the amount of the supplemental county excise is calculated using a percentage of net sales, then in the month the required total is met, the amount on line 6 will be *less than* the product of net sales multiplied by the percentage used to calculate additional retained revenue. In the final month of the supplemental county deeds excise fund collection, only the amount needed to reach the required total should be entered.**Calculation of remaining supplemental deeds fund.** Allotted Supplemental Deeds fund to be taken this fiscal year.
