## Form MVU-23 Instructions

---

The purchaser of a motor vehicle acquired for use, storage or other consumption in the Commonwealth of Massachusetts is required to pay a sales or use tax unless an exemption is specifically provided for in the Massachusetts General Laws or the Code of Massachusetts Regulations.

Massachusetts law provides for an exemption from the sales or use tax for transfers by an insured in connection with a claim under an insurance contract for the loss or loss of use of the vehicle. In order to be exempt from the sales or use tax you must meet the requirements of the law and complete and sign Form MVU-23. If you have additional vehicles, you may submit more than one Form MVU-23, or a spreadsheet listing the year, make, model, VIN and title number of each additional vehicle. Include on each page the name and address of the insurance company and the date. Be sure to fill in the oval at the top of Form MVU-23 if submitting more than one form or attaching a spreadsheet.

Your statements apply to each vehicle included in this affidavit, and any attachments, and are made under the pains and penalties of perjury. A statement which is made willingly and is false as to a material matter may be punished as a felony under MGL ch 62C, §73, or MGL ch 268, § 1A. Perjury is a serious crime and punishment can be severe.
