Application for Permit to Transport Fireworks (FP-006E)

I. APPLICATION INSTRUCTIONS

**All information on this application must be completed in its entirety.
Enclose a check for \$100.00 made payable to the Commonwealth of Massachusetts.**

- 1) Vehicle used to transport fireworks shall be so constructed that the fireworks are totally enclosed at all times.
- 2) The enclosure shall be protected by a suitable lock.
- 3) Appropriate placarding is required on both sides, front and rear of the vehicle.
- 4) Each vehicle shall bear the owner's name on each side.
- 5) Each vehicle shall be equipped with at least two 10-BC portable fire extinguishers.
- 6) Transportation must comply with 527 CMR 1.00 and 49 CFR
